## **Curtiss-Rose Home (Branford, Connecticut family)** BEFORE THE CONSTRUCTION OF THE NORTH BRANFORD DAM

This photo is from an interesting paper “Constructing the North Branford Dam and The Formation of Lake Gaillard” authored by Otto E. Schaefer, Senior Advisor for Land, Regional Water Authority (retired) and Theodore Groom, Ph. D. This paper is no longer up at the Totoket Historical Society website but we understand that a few hard copies are still available from the society. It includes a number of photos including the one above of the Rose home that was destroyed to construct the dam.

The provenance of the home seems a bit unclear but seems to have been the home of Jonathan<sup>4</sup> Rose Jonathan<sup>3</sup>, Jonathan<sup>2</sup>, Robert<sup>1</sup> Rose and at some later point was in the hands of the latter’s son Justus<sup>5</sup> Rose. See Christine Rose, *Descendants of Robert Rose of Wethersfield and Branford, Connecticut Who Came on the Ship Francis in 1634 ...* (San Jose, Calif.: priv. pr., 1983) pp. 154- 156, 191. It would appear that this home came to Justus through his relative Eunice Rose but more study needs to be conducted for the details. In any event, before the home was torn down prior to the building of the dam two rooms were preserved and can be seen at Yale University.

[Note: Justus<sup>5</sup> was the father of Abigail Rose whose portrait brought \$1,271,000 at recent auction. (See March 2015 *Rose Family Bulletin*, pp. 5627, 5630 for interesting information on this line. See special offer for members on this book page 5685 this issue).

You will see on the front page of this present issue a photo of their old home in Branford, Connecticut which was demolished to make way for a dam. Two rooms of this home were reconstructed at Yale University.

Please note on page 5682 the pension file (Florida War) of Nicolas M. Rose showing that Peter Rose was his father. This is unusual, but is worthy of note for it is always worthwhile to check the WHOLE pension file, not just a few selected pages.

## Hugh Barnwell Rose and Sophia Guerard Rose

CHARLESTON, SOUTH CAROLINA: BRANCH OF KILRAVOCK, SCOTLAND ROSES

From information and photo of Eugenie Steffens in the 1990s who is a descendant of Alexander Rose of Charleston, South Carolina who married Katherine Porteous. She directs researchers to *Genealogical Deduction of the Family of Rose of Kilravock* (Edinburgh, 1848, rpt 1982 Rose family Association) page 383. Further, she says that paintings of this couple were hanging at the bottom of the stairs at Kilravock (1992). Eugenie descends through Alexander's daughter Amelia Rose who married a Guerard.

The death record of Hugh Barnwell Rose was published in the Rose Family Bulletin 1998 and that of his wife Sophia Guerard Rose was published in the *Rose Family Bulletin* in 2004. Hugh's record shows he was son of Arthur Barnwell Rose and Emma Eliza Guerard.

Dr. Ben Lacy Rose, a charter member of the Rose Family Association who is now deceased, wrote an extensive essay on "Alexander Rose of Charleston, Colonial Merchant and Planter" and sent the Rose Family Association a copy. According to Ben, Alexander was the youngest son of Hugh Rose, 15th Laird of Kilravock castle and the laird's fifth wife, Katherine Porteous. Born in Scotland in the 1730s, he came to South Carolina prior to 1753. Ben's scholarly work on this family is heavily cited.

There are wonderful photos of various family members at findagrave.com. Check the Magnolia Cemetery but others will be found there in other cemeteries, too. Interesting family background is included. A condensed version of the will of Arthur Gordon Rose, dated 20 September 1875, was published in the *Rose Family Bulletin* March 1991 page 3583.

To the right, Dr. Arthur Rose Guerard, grandson of Arthur Gordon Rose, son of Amelia Laura Rose Guerard. This is cropped from a full length painting or photo but we were sent only a photocopy and it was so dark we are unable to show it in its entirety.

## Barzalai [Bazil] Rose of Surry County, North Carolina

Surry County Will Book Vol. I [copied by editor at the courthouse]

pp 127-128: 12 Feb. 1778, "Barzalai Rose aged fifteen years Orphan of Barzalai Rose Decd" is apprenticed to Robert Speer to the age of 21, to learn the art of carpenter's trade. Signed: Joseph Winston (Esq. of the co.); Robert Speer. Wit.: Jo Williams, C.C. Ack.: Feb. Court 1779. [This is how the record appears, and it is clearly in Feb. Term 1779 court minutes. Whether the clerk erred in copying the date of the bond as 12 Feb. 1778 is unknown for the original has not been located in the loose records at the State Archives in Raleigh, N.C.]

*Note: We have one test from a descendant of Barzalai Rose, later of Callaway County, Missouri, but would like to get another Y-DNA from another male descendant of this early Rose.*

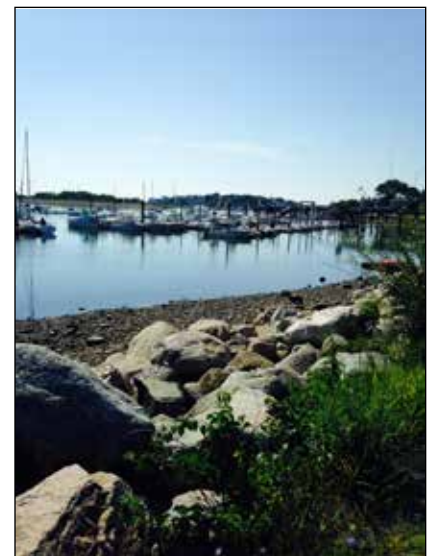

Affidavit: Lenawee Co., Mich., 21 Sept. 1875, Nicholas M. Rose, injured etc. Signed by x mark. Wit.: Charles B. Kinbell, Levi T. Slatie?

Affidavit: Lenawee Co., Mich., Nicholas M. Rose, age 65, resident of Grosvenor in said county, for Increase. Signed by x mark. Wit.: Ozro Hall, W. J. Scout. 13 Feb. 1875.

Affidavit: Lenawee Co., Mich., 23 Apr. 1855, Nicholas M. Rose, aged 43, resident of City of Adrian in said county, "that the deponent is an only son and child. That **his father Peter Rose enlisted when about fifteen (15) years of age in the war of the Revolution...**that his family are now dead." He further states that he enlisted by Capt. Lloyd Beall in City of New York, as Priv., for five years, in company commanded by Capt. Hows, Lt. May, Regiment commanded by Colonel Twiggs in the War with Florida Indians, he enlisted about 28 April 1840, etc.

Affidavit: 12 Feb. 1855, Nicholas M. Rose, aged 43, resident of City of Adrian, Lenawee Co., Mich., enlisted by Capt. Beall in New York for 5 years, etc., gives engagements and disability. That before enlisting he was an able bodied blacksmith. "**That his Father Peter Rose served in the War of the Revolution** and in the War of 1812 as a Private. That his said Father enlisted in the second New York Regiment during the Revolutionary War and served four (4) years and nine months or thereabouts for which he was palced upon the Pension list. That his said Father Peter Rose also enlisted as a Private in the War of 1812 for five (5) years and after being wounded and discharged, was again put upon the Pension list."

Affidavit: Lenawee Co., Mich., Delilah S. Hunter, is a daughter and only child of Eliza Rose deceased, that said Eliza Rose was a pensioner, that she died on 5 Feb. 1910 at age of 96, took care of mother, etc., makes application for the accrual of pension. Signed her name.

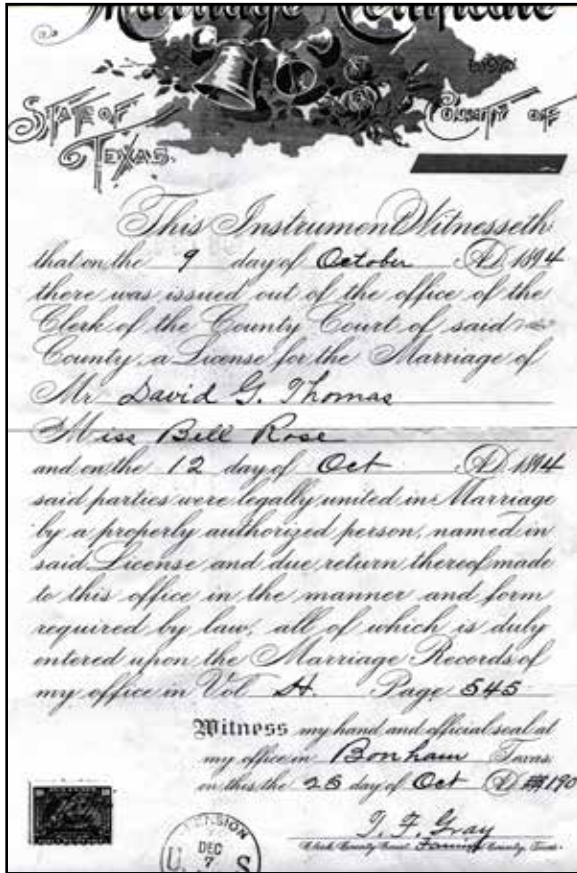

## Early Alabama Newspapers

When your editors first became interested in the family history, we experienced a great deal of difficulty finding clues to our Rose ancestry. We knew they were from the northwestern counties of Alabama and that Seymour's great-grandfather had removed to Madison County, Arkansas in the mid-1850s and then by wagon train to California in 1856. We had four very small children and very limited funds, but we contacted professional Pauline Gandrud for her assistance. For \$15.00 (oh, what a lot that seemed to us!) she was able to provide a census and some other information that put us on the right track. We were so grateful to her, her work, and her efforts to help, and ultimately began to correspond also with her sister Kathleen Jones. We kept that up for sometime as Kathleen was such a friendly woman and avid genealogist. We credit these two sisters with the start of our interest in Rose research. Willie Rose died 25 May 1910 in Macon County Alabama. The duration of his disease was six days and the cause of death was cold after labor. (Note: don't know what that means but "cold after labor" is listed as cause of death.) He was born in Montgomery County Alabama and was a four year resident of Macon County. He was a 24 year old farmer.

Certificate # 18:305

Harriett Rose, a resident of Mount Vernon, Alabama in Mobile County Alabama for two years, died 20 July 1910 of nephritis after an illness of one month duration. She was age 52 years and was married. She was buried at Hospital Cemetery.

Certificate # 22:8

Cornelius Rose, a laborer, died 26 October 1910 in Montgomery County Alabama after an illness of 3-4 months duration. The chief cause of death is unknown but rheumatism was a contributory cause.

### Year 1911

Certificate # 10:253

Mrs. L. N. Rose, a 63 year old housewife, died 3 November 1911 of acute indigestion and valvular heart disease in Jefferson County Alabama. She was visiting her son, N. Rose, and was sick only a short time. She was born in Jackson, Tennessee and interment was in Jackson, Tennessee.

Lizzie Rose died 29 March 1911 in Hillsboro in Lawrence County, Alabama. She wa age 61 years and 9 months and was a married white female. She died of carcinoma of the uterus. Her occupation is listed

as a midwife. Her father was John Kimball who was born in Alabama and her mother was Mary who is born in Alabama Lizzie is interred in Chylbate (sp) Springs.

William F. Rose died 4 June 1911 at Pike Street in Huntsville, Madison County, Alabama, his residence for 12 years. He died of Bright's disease and was a married farmer 74 years old. His father was James A. Rose who was born in Virginia and his mother was Mrs. Nancy A. Vacreis (sp) who was born in North Carolina. William is buried in Maple Hill Cemetery.

Certificate # 17:593

Frank Rose Jr. died 17 July 1911 in Mobile, Alabama of phthisic tuberculosis. He was born in Mobile, Alabama, was married, and was 41 years and 10 months old. His father is unknown and his mother is Mrs. Mary T. Rose.

Alex Rose died 5 November 1911 in Morgan County Alabama. No additional information.

Certificate # 24:425

John Rose of West Blocton, Alabama in Bibb County Alabama, a black laborer, died 11 February 1912 of pneumonia lobar at age 50. He had been a resident for 20 years and was widowed. He is buried in Blocton Cemetery

C Y Rose of Opp, Alabama in

Covington County died 25 February 1912. His occupation was turpentine dipper and he was a single colored male 20 years old. Cause of death was homicide from a pistol shot in the back.

Certificate # 7:550

Walter James Rose of Valley Head, Alabama in DeKalb County died 15 December. 1912. He was 2 years 7 months and 5 days old and had been a resident of DeKalb County for one year. He died of membranous croup and diphtheria. His father was Earl Rose who was born in Illinois and his mother was Mittie Rose who was born in Alabama. Interment was at Valley Head Cemetery.

"Waiandanch, Sachem of Meantaquit, Plt., hath entred an action of Damage against Jeremy Daily defendant.

"Mr. Lion Gardiner testifieth that hee was at the Iland when my son and Goodman Daily came over, and I heard that the Great Cannow was coming, and I went Down to meet them, and made a noise for them that were in the house, to follow me, and I mett my sonn and Goodman Daily coming up, and I asked them whie they puled not up the canow, and they said it was time enough, and I called them to goe to gett it up, and we all went, and could do nothing, and then we went agen, and she was full.

"JOHN ROSE testifieth, that when the canow was brought into the South harbor, my BROTHER, ANTHONY WATERS and Goodman Daily, did mend the canow, by putting 2 pieces into the side of her and upon that account they were to have the use of her, when their time was out, to carrie over their things.

## Anthony F. Rose

FORT WAYNE, INDIANA AND GERMANY

Anthony F. Rose was born in Washington township and has passed his life thus far within its borders. He has lived quietly on the farm his parents settled when they came to this region, and since the death of the mother and father has shared the old homestead with a sister, neither of them having married. They are among the substantial and dependable people of the community and have contributed in a commendable measure to the development of the township. Mr. Rose was born on January 17, 1850, son of Charles W. and Christine (Muesing) Rose, natives of Germany who came to America as children and were married in Washington township, settled on new land and spent the remainder of their lives in developing and upbuilding a home. They reared a family of twelve children, four of whom are living today. Named in the order of their birth they are Louisa, Anthony F., Lena and Amelia. The others, who died on the home farm, were Sophia, Eliza, Christina, Charles, Christian and three others who died in infancy. Anthony F. Rose was educated in the Washington township schools and early learned to apply himself to farm work on the home place. He inherited the family home on the death of his parents and is today the owner of 185 acres of fertile land in Washington township, where he carries on general farming and stock raising. He and his sister, who has shared the old home with him, are members of St. Paul's Lutheran church and take their place among the best people of the community.
