Rose Farm at Gettysburg



This beautiful photo is from Pinterest which also directs the reader to gettysburg.stonesentinels.com. This latter has many interesting photos including monuments, soldiers, etc. relating to this battleground. The owner of the famous Rose Farm was George Rose and his wife Dorothy of Philadelphia, Pennsylvania.

The farm of George and Dorothy Rose is south of Gettysburg on the eastern side of Emmitsburg Road. This is evidently the farm purchased by George Rose as evidenced by a deed recorded in Adams County Courthouse in 1858 and recorded in Book NN p 151.

From many accounts of the battle, the Rose Farm was in the midst of some fierce fighting during the battle. The farm was acquired by the National Park Service many years later.

Many years ago we went to the Connecticut State Library and spent many days there calling for all those ROSE probate files which at the time contained all the original papers. We abstracted them and have published many of those abstracts in our issues. Later, the library microfilmed the files and withdrew the originals. But now, all those files are scanned and available online!

The above collection is available at www.ancestry.com, which is a subscription website. It is titled Connecticut, Wills and Probate



Records, 1609-1999. According to the description, these records come from a collection of microfilm. Some localities and time periods may not be included because their records were not available to be acquired as part of this collection, or the records may have been lost or destroyed before the effort to collect them all began. But do check it for your Connecticut family - you will perhaps find those you seek.

The website at www.americanancestors.com is an amazing source also. It is the website of the New England Historic Genealogical Society on Newbury Street in Boston but it is not limited to New England search. Members of their society have easy access to wonderful records. Your editor recently found the original probate records of one of Seymour's ancestors, all scans of the originals. It would have taken us considerable research to just determine when and where he died, but by "taking a chance" and looking in various probate records he was easily found on this website!

And don't forget the many records available at no charge at www.familysearch.org. You do need to sign up but there is no charge. Try their different searches and you will be glad you did, we are sure.

We hope you enjoy the article in this issue by Russell Rahn. Though not a Rose descendant himself, you will see that he became interested in this family of Indiana, Iowa and South Dakota and put together some interesting information on the James and Jane (Conover) Rose family of Prince William County, Virginia through a branch that went west. Russell also included a photo of James Albert and Abigail Egbett Higbee Rose, probably taken at their marriage. We do thank him for his efforts especially since he is not a Rose descendant!

A Rose Family of Indiana, Iowa and South Dakota

Recently I acquired a collection of family history memorabilia dealing with the Rose family. The collection contained a variety of items (see listing). While not all of the material was strictly of a genealogical nature, by working through the various part of the collection, it was possible to put together a family tree of the Rose family. This pedigree covered about one century of the family, from the early 1800s into the 1920s. It is shown here, labeled 'Family Papers'.

It was then thought to be worthwhile to investigate a familiar internet genealogical site that also might have one or more pedigree charts already compiled viz. *familysearch.org*. This site did indeed provide a pedigree of the Rose family starting in the early 18th Century, and ending about the same time as the family papers had. It however, was more expansive for the family of Daniel Rose (b.1781), while the collection of family papers was more informative for the family of his son, Daniel Henry Rose (b.1817) and of his grandson, James Albert Rose (b.1856).




The back of the photograph is labeled "Grandma and Grandpa Rose. This expression is used only one time in the collection of paper ephemera and it refers to James Albert Rose (1856-1932) and his spouse, Abigail Egbert Higbee Rose (1860- . Considering the overall youthful appearance of this couple, it seems reasonable to suppose the photo was made at the time of their marriage, June 30, 1884.

The two sources have been kept separate in the family trees shown here simply because it seemed more interesting to see just what type of information had come from each of the two sources. Any reader wishing to merge the two trees can easily do so.

In examining the vital records available for this family, one thing becomes evident immediately. This family moved frequently! The family roots go back to England, and upon arrival in North America, they settled first in Virginia. By the 1840's, the family had made its first move to Indiana. The first four children of Daniel Henry Rose were born in Indiana, but the last six were born in Iowa. It appears that the Iowa "roots" went a little deeper and they seem to have remained there a bit longer. But once again, they decided to move west, and by the 1880s, the larger portion of the family had settled in the vicinity of Pierre, South Dakota. It is at this point where information about the family from the sources used comes to a close.

Ed. note: Our thanks to Russell Rahn for sharing his compilation with our Association members. There is no documentary proof that Jeremiah Rose is the father of the early James Rose of Virginia; if anyone is able to find anything definitive on the father of James Rose please do forward it so we can share it with members. We apologize for the darkness of the photo but we did not have the .jpg file to lighten it.



Acknowledgement

I would like to thank Christine Rose for willingly sharing the available data from the Rose family for inclusion in this family tree. Several of the details were not known to me and have added to the interest of this endeavor.

Family Source Material

1. A history dealing with the life and times of Daniel Henry Rose and family of Madison County, Iowa, for the years 1854 – 1877. This document is typewritten, double spaced, and about 30 pages in length. It was composed by James Albert Rose and contains the indication that he was about 75 years of age when he wrote it. This would place it around the year 1930.

2. A collection of about 80 additional sheets consisting of pages from the document which are either exact copies or are pages which appear to have been written and then rejected and rewritten by the author. There is some additional information in this collection of "extras" which is not found in the final draft and collation of the actual document.

3. An autobiography of James Albert Rose, which appears to be written around the same time as item number 1 above. The paper used appears to be the same and the typeface and fonts appear to be the same, suggesting the same author.

4. Assorted pages, mostly correspondence dating from 1918 - 1931, consisting largely of genealogical topics. The letters clearly indicate that the person who accumulated this was interested in constructing a genealogical table and family pedigree. She is Mabel R. Kendle, who is a granddaughter of Daniel Henry Rose. The collection consists of about 50 sheets, and while it clearly shows an interest, much of the truly useful, detailed information is not present. It seems that most of the responders were either unsure of the information or just did not know of it at all.

5. A collection of correspondence in original envelopes covering the years of 1884 through 1942. The total number of pieces is slightly over 100 total items, and the largest decade represented is the 1930s. These items are primarily of a "family letter" nature; which reflect the fact that although the family had become widely distributed throughout the United States by that time, it made at least some effort to stay in touch. It is also evident that the family members doing the corresponding cared for one another.

Oscar Rose of Massachusetts and Pennsylvania

LACKAWANNA, SUSQUEHANNA AND LUZERNE COUNTIES ROSE FAMILY

This photo was sent sometime ago by members Thomas and Joyce Rose (now both deceased). They took it when noting it on a trip though it had no connection to Tom's own Rose family. Editor did a bit of searching and finds that Oscar is listed as age 9 in the home of George W. Rose and his wife Alviram E. Rose in the



1900 Census of Luzerne County, Pennsylvania though it appears to show his middle initial erroneously as T. Further search indicates that later census confirms that Oscar H. of the tombstone was born in Pennsylvania. The 1940 Census of Springfield, Hampden County, Massachusetts shows him at 2947 Main Street.

A search of military records disclosed that there is a WWI Draft card for Oscar H. Rose of 429 North St., Rochester, N.Y., that he was born Feb. 3, 1891, and that he was born at West Pittston, Pa., occupation moulder. He was single at the time. Later, in WWII draft, he is shown as Oscar Henry Rose, 2947 Main St., Springfield, Hampden Co., Mass., age 51, born West Pittston Feb. 3, 1891, Penn., and the person who would always know

his address listed as Mrs. Fannie Rose at the same address.

There was an early Rose in that Pennsylvania area: Jonathan A. Rose, parentage unknown, born ca 1810, New York (1860 and 1870 census), death data unknown. He married, date and place unknown, Lucinda Eggleston, 6 March 1826 (d.c.), Pennsylvania (1900 census) or New York (earlier census), said to be born Cortland, New York (not confirmed). She died 12 February 1907 (d.c.), Harford, Susquehanna County, Pennsylvania, and is buried in the Brooklyn Cemetery, Susquehanna County, Pennsylvania. Among the children of this Rose was a son George Washington b. 12 Aug. 1855, m. Alvira E. ---. Further research should turn up more on these Roses but it does appear that Oscar H. Rose of the above tombstone is from this Pennsylvania family.

Bryant, Preacher of Gospel, she not previously married, he not previously married, no children under 16. Signed: Dora Margaret Rose. Wit.: Julia Louk, William J. Turner.

Death Certificate: Louis Martin Theodore Rose, at residence 28 years, in Calif. 35 years, died March 1, 1908, married, white, birthdate not known, age 78, married, born Germany, rancher, father and mother marked don't know. Informant: Dora Margaret Rose, Garberville, Calif.

Affidavit: Louis M. T. Rose, married yes (her name not given), married June 1872 at Rohnerville, Humboldt Co., children living, 5: Louis Rose Oct. 1877, Louise Rose now (Nellis) Apr. '71, doesn't list others. Signed. Dated: June 4, 1898.



CAPT. LEWIS ROSE -- born Oct. 11th 1749 in Bingen Germany, died 20th February 1829, Harrodsburg, Kentucky. Buried on old Rose farm three miles east of Harrodsburg. Came to America 1764. A Christian Patriot Devout Elder in Presbyterian Church. Donated \$500 to Centre College, Danville College 10 miles South of Harrodsburg.

In 1937 some of the earth from the gravesite of the Rose farm was taken to Pioneer Park in Harrodsburg Cemetery where a crypt was erected. Leslie M. Rose of Yakima, Washington was largely responsible and was at Harrodsburg for the purpose of doing this. The erection on 16 July 1937 was sponsored by the Jane McAfee Chapter D.A.R.

Sometimes we can hunt and hunt for a document or record that will provide proof of a relationship but not finding it, we have to depend on building a case based on the Genealogical Proof Standard. However, in the following, persistence did turn up a surprising record. After researching this family for several years and building up a huge body of evidence but no record actually documenting the relationship of father/son, the following was located. You can imagine the "whoopee" that vibrated throughout the N. C. State Archives when editor found this!



Why make the effort to seek out original documents at the National Archives? Following is one good example. The National Archives has a series of booklets called "Preliminary Inventories" which were originally meant to preliminarily describe various record groups. "Final" publications were never made. These, called PIs, are numbered. The PI 17 is *Records of the Office of the Adjutant General's Office* The PIs themselves have entry numbers and in this one Entry 91 describes the group of loose original U.S. Army Enlistments from which the two page enlistment of Philip H. Rose was taken and potocopied.



For those of you tracing Massachusetts families, try their *Massachusetts, Town and Vital Records, 1620-1988.* Many of these are actual images of the original records!

And, how about the U.S. Headstone *Applications for Military Veterans, 1925-1963.* An example is that of James G. Rose, shown as born June 9, 1843, died May 18, 1911, enlisted July 9, 1864, of Tellico Plains, Tennessee, 7th Corporal, Third Tenn. Mtd. Inf., Union Army, buried in Green Cove, head of Tellico River, Monroe County, Tennessee. Applicant was Percy Swainsin. That from a scanned copy of the actual application which also includes additional information. Try it!
