JOHAN D. ROSE. This name will be at once recognized as that of the editor and proprietor of the *Callous Herald*, published at Hardin, and his many friends will be pleased to see an account of his life and labors in this ALBUM. The life of a country editor is one which calls for an unfailing supply of tact, a keen appreciation of the wants of the people in regard to news, and the faculty of wielding scissors and pen rapidly and efficiently. The journals published in our smaller towns and villages are expected to furnish their readers with all the important items of local and general information, and few consider that the facilities afforded the editor, are much less than those of his city brother, with whose sheet his own must compete in interest. No one, therefore, is more deserving of credit when successful, or of sympathy if unsuccessful, than an editor.

A brief glance at the ancestral history will show whence Mr. Rose derives his persevering, enterprising spirit, and the mental qualities which, combined therewith are giving him success in the journalistic field. Going back a few generations we come to Francis M. Rose, a native of Virginia, and the son

Francis M.¹ Rose, middle name not confirmed, was born ca 1772 (1850 census Giles Co., Tennessee) in North Carolina (ibid.). He died in January 1856 according to the probate of his estate in Lamar County, Texas. He evidently removed to Texas to be with his sons Carroll and Henry M. Rose.

The earliest record found on Francis is in records of Knox County, Kentucky.

The above Minute Book entry indirectly helps to identify Francis as the Rose of this biography because of the appearance of the names of Daniel Cutbirth and Benjamin Cutbirth. It is known that Francis had a second wife named Elizabeth Cutbirth.

However, there are some serious errors in the biography which is often the case with these early "mug" (so-called) books. Researchers should test all statements it contains. Dear Readers,

We have received an influx of emails in the past few weeks that mix 2-3 different Rose families. It creates problems by linking families which can be conclusively proven by YDNA not to be related to each other. We know that researchers want to find their correct family and in some cases are led into accepting the wrong posted family as theirs. They may then pass that erroneous information on to others who then perpetuate the error.

Though posted family trees can be very valuable and helpful, especially when they lead to living descendants or to posted photographs and documents the family may have, those trees must be proven. Not by the posting or linking to other family trees, but proven by documentation. Each generation needs to be verified through records such as birth, marriage, death, probates, war records, local land records, federal land records, etc. Unfortunately, though there are many good records available on the Internet, not all documents can be found there which may entail some onsite research. For example, marriage records of a town or county may or may not be available on the Internet. But, they should be available in the courthouse or Town Hall.

If you cannot travel to the location to search, do you have a relative who can? Or consider hiring a researcher in that county. Also, check to see if there is microfilm available or if anyone has published the needed records of the county. That is not as satisfactory as checking the original, but if you do find the record in a published book you can write a letter to the facility holding the document and order a photocopy.

Some personal news. I (editor Christine) no longer lecture or conduct client research. However, that does not mean that I (and husband Seymour) no longer research. We are devoting considerable time to research in New England and New York to finally spend time working on Seymour's many New England non-Rose connections. Though I am taking a different direction in genealogy I nonetheless still answer Rose inquiries, provide Rose reports, and assist others with their Rose families.

In answer to questions about the change in my postnominals, the Board for Certification awards the honor of Certified Genealogist Emeritus to those who had a "long and distinguished career" and are now retired or semi-retired. I was honored to accept this and therefore now have "Certified Genealogist Emeritus" after my name instead of "CG" and "CGL."

Readers are reminded that a huge amount of ROSE material has been transferred to the New England Historic Genealogical Society in Boston, Massachusetts and is available for viewing there. Any readers not acquainted with that library and repository will find that membership in that society will not only get access to their many holdings, it will also give access to www.americanancestors.org. The latter has a digitized database of all the long-running New England Register, hundreds books of vital records, and many, many other digitized or compiled records plus a huge number of valuable published articles. Take a look!

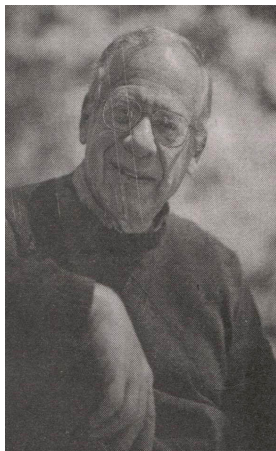

of a German emigrant. Francis Rose became a pioneer in Giles County, Tenn., and there his son, William W., spent his entire life. The latter married Lucinda Hickman, a native of Tennessee, who is still living in Giles County, being now eighty-five years old.

In the family of the couple just mentioned is a son, Francis M., who was born in Giles County, Tenn., November 8, 1822. He received an academic education, and in his early manhood began teaching, carrying on his labors in his native State until 1849, then going to Missouri and continuing his profession there. After a time he joined an exploring expedition, and traveled with wagons and on horseback through the territory now embraced in Kansas, Nebraska, and the Indian Territory. In July, 1853, he came to Calhoun County, Ill., and began teaching in the northern part of the county. With the exception of one year, this county has been his home since that time. For a time he was engaged in dealing in staves, which in the early history of the county was extensively carried on, but the greater part of his time has been devoted to farming and school teaching. His family consists of six children, the subject of this sketch being the third in order of birth.

In this county, December 30, 1855, Francis Rose was married to Lavina Leeper. That lady was born in Marion County, Ind., February 15, 1839, and her parents were natives of Kentucky and Virginia, respectively. She accompanied them to St. Charles County, Mo., in 1849, but a year later they took up their residence in Calhoun County, this State, where both died in 1852. Besides our subject the family of Mr. and Mrs. Francis M. Rose includes William T., whose home is at Summit Grove; Mary L., wife of T. N. Sharp, living in Carlin Precinct; Francis L., whose home is in Crater Precinct; Henry A., who lives in the same precinct; and Jesse L., who died when eighteen years old.

The gentleman who is the subject of this biographical sketch, was born on a farm in Crater Precinct, October 22, 1860. He was reared and educated in the county, beginning to assist his father on the farm when quite young, but devoting every spare moment to his studies. He had an ar-

dent desire for knowledge, quickness of comprehension, and the strong will which enabled him to acquire information while others were pursuing the sports of the young. When twenty-one years old he began teaching, making that his business until 1890. He imbued his pupils with something of his own spirit and love of learning, and won their good will by his heartfelt sympathy. During the period which he devoted to pedagogy, Mr. Rose was also a representative of some of the best fire and life insurance companies in the United States. On January 25, 1890, he purchased the plant of the Calhoun *Herald*, and is now devoting himself with assiduity to the work of an editor. He has a job office, and is working up an excellent business in that department. He continues his insurance business, but gives himself particularly to journalism.

For a few short years Mr. Rose enjoyed a happy married life, having been wedded August 19, 1885, to Eva M. Nevius, who passed away August 4, 1889. Mrs. Rose was born at Summit Grove, this county, November 7, 1860, being a daughter of D. S. H. and Sarah Nevius. She was an intelligent, lovable woman, whose early death is mourned by many sincere friends. She left one son, Guy D. Mr. Rose belongs to Calhoun Lodge, No. 444, I. O. O. F. His bearing is gentlemanly and courteous, his disposition kind, and his habits manly and upright. He is therefore well respected by those who know him and his future career will be watched with great interest.

[Note that this mentions Military Land Warrant. Her husband was Bennett Rose a War of 1812 veteran who died in 1852. His widow applied for remainder of bounty land due to him as a veteran.]

Albert Dempsey Rose (Berry², Benjamin¹) was born 24 January 1828, Robertson County, Tennessee, and died 1 July 1911 in Oklahoma. He married 10 October 1850 in Christian County, Missouri, to Loiza or Louiza Angeline Sprouse who was born 29 August 1829 in Madison, Tennessee and died 25 October 1900 in Oklahoma City, O(klahoma).

Albert Rose served in the civil War in Co. 3 41st Inf. Reg., Illinois Vol. (His file available at the National Archives.)

Among his children were Amanda Ann (grandmother of Mildred Bachman), Sarah, and Mary, all pictured to the left. This was from an old xerox copy and does not reproduce well but nonetheless is wonderful to have.

(Editor Christine and Mildred corresponded for years before Mildred died. We suspected a possible relationship between her family and that of editor Seymour but unfortunately did not prove that until after YDNA testing became available and by that time Mildred was deceased.)

“This register includes the records for those buried and memorialized at our World War I and World War II overseas, military cemeteries, along with those names on the Walls of the Missing at the East Coast Memorial, West Coast Memorial, and Honolulu Memorial. Burial information can also be found for those interred at Corozal American Cemetery and Mexico City National Cemetery. This register does not include individuals who died overseas in World War I or World War II and were repatriated to the United States for burial.”

Clicking on WWII and last name of ROSE turned up over 200 entries. The information includes rank, number, regiment, enlistment information, death and burial. The listings are accompanied by a photo of the cemetery.

JOHN ROSE

THE SOLEBURY TOWNSHIP, BUCKS COUNTY, PENNSYLVANIA
ROSE FAMILY

Editor's note: This group of Roses from Solebury twp., Bucks County, Pennsylvania are very interesting and are a separate group of Roses not related to the Andrew Rose family early of this county. One of the later descendants of this family was Thomas Elwood Rose who as the "engineer" of the famous tunnel and escape from the notorious Libby Prison in Richmond, Virginia during the Civil War. We have published articles on Thomas in various of our issues and also the poignant account of his recapture, but he did survive and is buried in Arlington Cemetery. His prominent tombstone there was the subject of yet another article in one of our past issues. Those of you who are interested can "google" him to learn more.

The progenitor of this family is John Rose, birth unknown, died in Dublin, Ireland sometime before 29 July 1729. He was probably the John who died 1728 "from near Drogheda, a Friend", and buried 9th month 1728 at Dublin, buried there at the Friends Burying Ground on Cork Street in Dublin. he married 24 Feb. 1687, Dublin, Ireland, Susanna Rolton [or Bolton?]. She removed to Pennsylvania with three of her sons, and may have have died at Bristol twp. near Germantown, Philadelphia 1-8-1739/40. She is buried at the Friends Burying Ground in Germantown. (Her death is unconfirmed.)

Widow Susannah and three sons John, Thomas and James removed to Pennsylvania. Because of the certificates of removal that have been preserved by the Religious Society of Friends in Ireland (copy provided to us by Susan Verzella), we have good proof of the origin of this family. From her certificate:

To Friends of Pensylvania in America - Greetings

Dear Friends

Whereas Susannah Rose of this city widow hath intention of removing hence, along with her three sons viz Thomas James and John Rose, who are about to Transport themselves in order to settle in your parts and Desiring our certificate concerning her. This may therefore certifie that the said Susannah Rose was Educated by her parents in the Profession of Truth, and about Forty years ago was married amongst Friends to her late Husband John Rose who is not long Deceased and so far as we know she has been of an orderly Conversation and is clear of Debt and tho' it might not Seem advisable to Enter upon such a long voyage to another country in her old age, yet considering that affection to her children Induces thereto, we could not seek much to Disswade her, but do earnestly Desi(re) the Lord may Support her, through the Difficulties and Trials She may meet with, and that your Christian care and tenderness towards her may not be lacking -- the Salutation of Dear love to you, we conclude your Friends and Bretheren in the truth. Signed on behalf of our ---? Meeting Held in Dublin the 29th of the 5 mo. 1729. (Here follows eighteen signatures.)

From the certificates of her sons we find some interesting information. The certificate for Thomas Rose "of this city Linnen Weaver" states he "hath Intention of removing there into your parts (along with his mother & two brothers). It is further stated that he was educated by his parents in the profession of Truth, served his apprenticeship, and "as we understand has been of an orderly conversation and diligent in attending our Religious Meetings and upon inquiry we do not find but that he is clear of debt and from any Engagement on account of marriage." This is dated the same as the above certificate, and signed by eighteen others. The certificate for John Rose is dated the same and has eighteen signatures. It states that he was educated in the profession of truth by his parents and has been dutiuful to them, orderily and diligent in attending religious meetings, "as likewise in his service to his brother in the employment of Linnen Weaving and upon Enquiry we do not find but that the said John Rose is clear of debt and from any Engagement in relation to marriage." The certificate for James Rose is dated the same date at Dublin, states that he was educated by his parents in the profession of Truth, "and as we understand served his apprenticeship Honestly to his Kinsman, a Friend of this City but sometime after Entitled Himself in the army wherein he continued about a quarter of a year, and then was disbanded so Returned to his Parents and comes to our Religious Meetings and seems sorry for his said outrunning and acting contrary to his Education." This further states that he is "clear of debt, and from any Entanglement on account of marriage," and is signed by fifteen others.

From Albert C. Myers, *The Irish Quakers in Penn. 1682-1750*, repr. 1969):

ABINGTON MONTHLY MEETING in Montgomery Co. Established in 1683.

JOHN, THOMAS, AND JAMES ROSE, received 5 Mo. 27, 1740, from Ireland.

John Rose received a certificate to Buckingham in 1734. Later he was living in Germantown. James Rose received a certificate to Buckingham in 1735. Thomas Rose m. Margaret Lucken, in 1738, and resided in Germantown. For many years he served as overseer and elder of Germantown Meeting and as clerk of Abington Monthly Meeting. He died 9 Mo. 17, 1785, aged 84 years and 3 months.

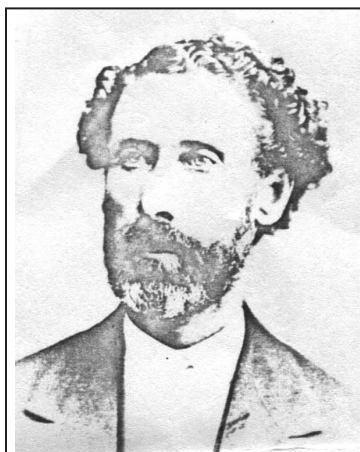

OLD WAR PENSION FILE

Abstracted by editor at the National Archives. Researchers should not overlook the separate set of "Old War" Pension files available. These often include disability from early wars prior to acts that specifically provided for their disability benefits. A browsable index is available at www.familysearch.com; images of the files themselves are not available there but images of the index are and can be searched. United States Old War Index 1815-1926.

The "Old War Index to Pension Files, 1815-1926" (from NARA T316) consists of index cards to pension files based on death or disability principally in the War of 1812, Indian Wars and Mexican War.

These were to include pensions mostly for U.S. Regular Army soldiers and Navy personnel. Yet, we find many volunteer soldiers listed. A large number of Mexican War (1846-1848) soldiers are included. (Some Civil War soldiers are also included if they had served prior to the Civil War, i.e., usually the Mexican War.)

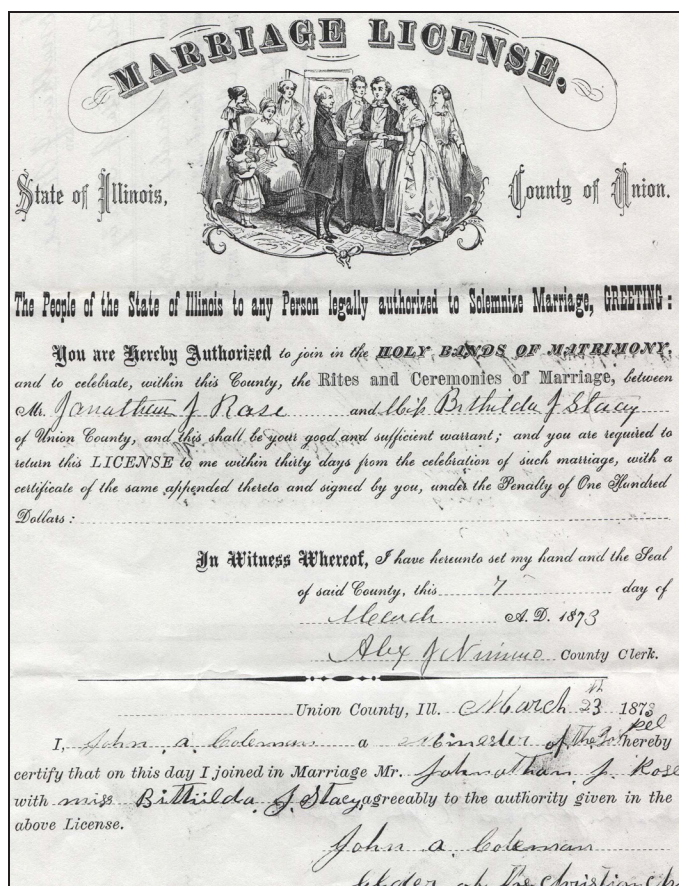

[It is to be noted that Robert Speer who had married Elizabeth, daughter of Bazil Rose, does not sign. From other papers it is indicated that he lived in Limstone County, Alabama, and this may be the reason.]
