

## George W. Rose Home, Hancock County, Illinois



Sent by George Sparrow from 1874 *Atlas of Hancock County, Illinois*. This is the home of George W. Rose, dealer in monuments and tombstones, in Sonora, Illinois. Does anyone identify this George W. Rose? The 1880 Census of Hancock County, Illinois #249/250 is of Elizabeth Rose, 63, born Va., keeping house, born Virginia, both parents born Virginia. She is listed alone but just before #250/251 of George W. Rose Sr., age 39, marble cutter, born Ohio, father born Ohio, mother born Virginia. His wife Margaret A. was born Illinois, and son George W. Jr. with them was 18, marble cutter, born in Iowa.

It should be noted that there is a George Rose in the 1870 Census of Hancock County. He is listed as age 29 born Ohio, Maggie age 26, and George aged 8 both born Illinois.

George's tombstone photo on findagrave.com indicates he was buried in Oak Grove Cemetery in Hancock County and that he served Civil War Co. D 11 Mo. Inf.

Editor has examined his complete file at the National Archives. It is a very small file (in contrast to most C.W. pension files). This shows he died 5/4/1908, and that in 1898 he made an affidavit from Hamilton, Illinois that he married Maggie Augusta Luce 7 September 1859 in Belville, Illinois. [St. Claire Co.] He had one child living at the time, George W. Rose Jr., who was born November 3, 1861.

## Richard Rose, Southampton County, Virginia

FATHER OF BURRELL ROSE OF EDGECOMBE COUNTY, NORTH CAROLINA



What would seem to be the simple will of Richard Rose of Southampton County, Virginia is fraught with questions. It would seem from records of Edgecombe County, North Carolina, that a Robert Rose of the latter county should also be a son of this Richard Rose. Robert did have dealings with Burrell Rose in North Carolina, and a great deal of research by a number of Roses would tend to support this. If so, why didn't Richard Rose name Robert in his will? Had he already settled with Robert? If so, why didn't he mention it in the will as was common?

Richard<sup>3</sup> Rose (William<sup>2</sup>, William<sup>1</sup>), born probably ca 1696, died between 5 July 1765 (date of will) and 10 October 1765 (will proved) in Southampton County, Virginia. He was of Saint Luke Parish at the time of making his will.

Richard married, date and place unknown, wife unknown but she was living when he made his will.

Will Book 2 pp. 146-147, will of Richard Rose of parish of Saint Luke, county of Southampton, to "my loving

wife" [does not name her], my best? feather bed and furniture, one spinning, one lomb [sic, loom], one box iron, one iron pit, and 1/2 of my pewter, and all stock of hogs that I now own with five barrels of corn, the stock of hogs and corn to her and her heirs forever [but the other he has designated for life]; to son Burrell Rose one feather bed and furniture, one chest and iron pot, some chairs, one frying pan and 1/2 pewter; to daughter Mary Rose after death of my wife the bed and furniture spinning wheel loom? box? iron, iron pit and 1/2 of my pewter that I lent my wife. Residue to be sold, debts paid, and residue between son Burrell Rose and daughter Mary Rose. Appoints son Burrel Rose and Amos Harris executors. Dated: 5 July 1765. Signed: Richard (his R mark) Rose. proved: 10 Oct. 1765, "and on the motion of James Jones/the executors refusing to qualify/who made oath according to law," certificate granted him for letters of administration.

Benjamin M.<sup>6</sup> Rose (Matison A. "Matt"<sup>5</sup>, Benjamin M.<sup>4</sup>, Wiliam<sup>3</sup>, William<sup>2</sup>, Thomas<sup>1</sup>) was born 15 July 1873 (WWI Draft Registration), and died 15 May 1929, Packard, Whitley Co., Ky. (d.c.). He married, Ida Rickett (from d.c. of son Everett E. Rose Sr.). According to information on an old family photograph of Ida (provided by Karin Jones), she was born 11 April 1876, Kentucky, and died 19 December 1966, Cincinnati, Ohio. [Note: d.c. = death certificate.]

## Obituaries from Tennesee Newspapers ante1851

Obituaries from Early Tennessee Newspapers 1794-1851, ed. by The Rev. Silas Emmett Lucas Jr., (Easley, S.C.: Southern Historical Press, 1978). [This book is a valuable source for those tracing Tennessee ancestors.]

ROSE, Miss Almedy, Died in Jackson. *Nashville Whig (Tues., April 21, 1846)* 

ROSE, David J. New Orleans, a passenger. Died on the Steamer *George Collier* about 80 miles below Natchez, scalded to death. *Daily Republican Banner*. (Tues., May 14, 1839)

ROSE, Maj. Neil B. In the 58th year of his age. Died on the 28th, a native of N.C. and an early settler of Huntsville, Ala. *Daily Republican Banner*. (Tues. Mar. 6, 1838)

ROSE, Dr. Robert H. Died in Shelby Co., Tenn. National Banner & *Nashville Daily Advertiser*. (Tues., Aug. 27, 1833). Editor's note: Maj. Neil B. Rose was a member of the Alexander Rose family of Scotland and North Carolina who had YDNA connections to Rev. Robert Rose of Virginia and North Carolina.

Dr. Robert H. Rose was a member of Rev. Robert Rose's family. His wife Frances was a sister to President James Madison. They had a son James M. who died at the Alamo. Descendants reported Dr. Rose's death occurred at his home in Tipton County though the news item states it was Shelby County.

### Benjamin Rose Family of Robertson County, Tennessee Connected to the John and Lucy (Bennett) Rose Family

Benjamin<sup>1</sup>Rose was born between 1770 and 1775 (census), thought to be born in North Carolina though unproven. He died between 3 August 1833 (date of will) and the end of August, for his will was proved August Term 1833.

He married, date and place unknown but probably before 1794, Mary "Polly" ---, born ca 1770-1780 (census) who survived him. Her death date is unknown but she was living 12 February 1849 when she signed a deed with her son Vincent D. Rose in Robertson County. It has been suggested that her maiden

name may have been Stark, but there is no confirmation. This is based on mention of an uncle Tom Stark in an old family letter (see later) though his relationship as uncle does not prove that Mary was a Stark. There is also some thought that it could be possible that he is the Benjamin Rose who married Mary McKim 22 October 1790 in Nelson County, Kentucky, but there is nothing to prove or disprove this possibility.

There were two particularly avid researchers of this Rose line, i.e., Mildred Bachman and Arlo Dean Rose, both now deceased. Editor Christine had correspondence and exchanges with both for years, and both were attendees of early Rose Conferences of the Association. Unfortunately, both died before the wonderful tool of YDNA testing became available. How happy they would have been (as we were!) to discover that their Benjamin Rose was related to editor Seymour's own Rose family of John and Lucy (Bennett) Rose through a descendant named Abner Rose. However, we have not yet discovered just how the two families are connected. This group is also connected to member Anita Marcoline who is a descendant of a John Rose of Centre County, Pennsylvania, to members who trace Abner Rose including Mattie Mitchell, Edward "Ted" Rose, James Burt Rose, Laura Rose, Elena Thompson, Kevin Rose, Brian Rose, Rebecca Williams as well as deceased member Rose Houston through her ancestor John Rose of White County, Tennessee. as well as other correspondents.

We can establish that Benjamin Rose (Arlo's ancestor) was in Rob-

ertson County at least by 1808 through an estate record in Will Bk 1 pp. 306-307, Inventory and Amt Sales in estate of Solamon (Squire?) decd, 18 Oct. 1808 [this may be Johnson Squire instead], p. 307, includes: Cotton Collards & fodder to Benjm Rose \$ .50.

The photo is taken from a newspaper article in (Kansas) published in 1981, photo by staff member Jerry Clark, in an article by Tom Weber. This article highlighted Arlo's work on the Rose family and his intended attendance at the first Rose Conference held in Ames, Iowa in 1981.

Rose of City of Philadelphia, to Board of Vestryman of Gloria Dei Church, \$100 etc.; to Mary Esler widow of my dec'd nephew John Knox Esler, \$200; and if I survive sd Mary Esler, then \$200 unto her 2 children Louis and Rebecca Esler; household goods to nephew Charles Dubue? Declarations of Intention, papers that are filed 2 to 5 years before the final papers on a citizenship (depending upon current law at the time) are important documents and should always be sought for your immigrant ancestor. This one is at familysearch.com and shows August Rose of Pocahontas County, West Virginia who was born in Luthorst, Germany on 6 April 1857 applying. It also provides his port of entry in Hoboken, New Jersey allowing those who search for him to further research for his passenger list.

## Hon. George M. Rose

FAYETTEVILLE, NORTH CAROLINA

HON. GEORGE M. ROSE. A life is valuable to the world both for its service and its character. On the score of service few men could desire a better record than that of George M. ROSE, for half a century one of the foremost lawyers of Fayetteville bar. Throughont a busy lifetime, beginning as a soldier in the war, various



public honors and the widespread esteem of his fellow citizens attest the quality of his manhood and the breadth and uprightness of his character.

Mr. Rose was born at Fayetteville June 5, 1846,: son of John M. and Jane (McNeill) Rose. He is of Scotch ancestry on both sides. His grandfather, Duncan Rose, was during the decade of the '30s clerk of the Superior Court of Person County. John M. Rose was born in Person County, about 1840 moved to Fayetteville in Cumberland County. In the maternal line Mr. Rose is identified with several families whose names are prom inent in North Carolina history. His mother was born in Cumberland County, daughter of George McNeill. The wife of George McNeill was a sister of Chief Justice Ruffin. Mrs. Jane McNeill Rose was a first cousin of James C. Dobbin of Cumberland County, who served as secretary of the navy in the cabinet of President Fillmore. One of her brothers, Rev. George McNeill, Jr., was the first editor of the North Carolina Presbyterian, now the Presbyterian Standard. Another brother was Rev. James H. McNeill, who was colonel of the Fifth North Carolina Cavalry and was killed in action March 31, 1865. The family are also related to the Camerons and the de Roulhacs of Hillsboro.

George M. Rose was reared in Fayetteville, attending Donaldson Academy and from there entering Davidson College, where he was a student two years. From Davidson he went to Virginia Military Institute. He was one of the famous class od young boys, who went out from the school in 1864 and engaged in the battle of Newmarket. In the Confederate army Mr. Rose became adjutant of the Sixty-sixth North Carolina Regiment. He surrendered at High Point, North Carolina, May 2, 1865. He was one of the youngest soldiers and officers of the war between the states.

The war over, he resumed his education in the University of North Carolina, finishing his literary course and taking his law there under Judge Battle. He was graduated from the university in 1867 and in the same year began practice at Fayetteville. During the years that have followed Mr. Rose has attained distinctive leadership in the profession of North Carolina. In the famous campaign of 1876, when Vance and Suttle were rival candidates for governor, Mr. Rose was elected to the Legislature from Cumberland County. He thus took part in the restoration of the democratic party as the governing factor in North Carolina. He was again a member of the Legislature in the session of 1881 and was speaker of the House in the session of 1883.

Since that time he has not been a candidate for any public office but has devoted his time entirely to the active duties of a large general practice. He is division counsel for the Atlantic Coast Line Railway, and was general counsel of the old Cape Fear and Yadkin Valley Railway prior to its incorporation into the Atlantic Coast Line System.

Mr. Rose married Augusta Jane Steel, and has the following children: Dr. A. S. Rose; Charles G. Rose, who is a graduate of the University of North Carolina and law partner with his father, and served in the Legislature in 1911; Jennie, wife of Mr. B. A. Morgan, an attorney and banker of Greenville, South Carolina; John M. and George M., cotton merchants at Charlotte; Thomas D. Rose, electrical engineer connected with the Consolidated Gas and Electric Company of Baltimore; an Miss Lucy Rose, who resides with her parents.

Dr. A. S. Rose, oldest son of Mr. and Mrs. George M. Rose, was a highly accomplished and successful physician at Fayetteville and died February 15, 1918. He was born and reared in Fayetteville and was forty-five years old at the time of his death. His life and services were such as to deserve the following words that appeared in a Fayetteville paper at the time of his death: "From childhood he had shown those qualities which go to make a fine strong character—a high sense of honor, faithfulness to duty, kindness of heart, industry and energy, and a laudable ambition. After graduation in the high schools, Doctor Rose entered the drug establishment in Fayetteville of Mr. H. R Horne, where he became a thoroughly equipped pharmacist. Later he entered the University College of Medicine in Richmond, Virginia, and graduated and began

practicing at Fayetteville in February, 1901. He built up an extensive practice in the city and the surrounding country, and his large circle of patients trusted, esteemed and loved him, 'Doctor Rose' being a household name dear in many families. In his young manhood he was made a deacon in the First Presbyterian Church, was church treasurer and later chosen a ruling elder, which high church office he was holding at the time of his death. He was a member of the North Carolina State Medical Society, the American Medical Society, and the Cumberland Medical Society, being at one time president of the latter.''Dr. A. S. Rose married Miss Jean Evans, of Cumberland County. She and three children survive, Susan, Augustus S., Jr., and Jean.

## Richard Rose, Revolutionary Soldier from Virginia

Some Family Connections

Left: Stephen Austin Rose and his wife. Stephen was a son of Stephen<sup>2</sup> (the latter raised by Richard<sup>1</sup>Rose). Stephen<sup>2</sup> was a veteran of the Black Hawk War and left a valuable Bounty Land File regarding his service and application for federal land.

John is not sure about the identity of those in the old tintype at the right , but says: "We suspect that the men in the old tintype photo could be William J. Rose 1837-unknown, James Newton Rose 1842-1879, or James Franklin Rose 1844-1898. They were the three brothers who served in the same Texas unit during the Civil War.

All we know is that the photo was labeled "Rose brothers". Since it was passed down through a descendant of Stephen Rose 1809-1880 (the father of those three men) and based on the age of the photograph and apparent ages of the men, it is believed that the photograph shows at least two of those three brothers."


Member Dr. John H. Rose of Texas has done a great deal of research on the family of Richard Rose, a Revolutionary war soldier of Virginia., later of Kentucky, Illinois and Indiana. John is very fortunate to have some wonderful photos and tintypes and has shared some of them with us. (Some of the others will be published in future issues.)

Richard<sup>1</sup> Rose married first, data unknown. She was evidently the female aged 26/45 (unless this was a daughter) in the 1820 census in Scott County, Indiana, but died before his second marriage in 1821. It is likely that she is named Elizabeth --- for the marriage record of Mary Rose in Floyd County, Kentucky in 1808 lists her as daughter of Richard and Elizabeth Rose. If Mary is daughter of the subject of this report, this would give us the name of Richard's first wife. [Ed. note: I have conjectured that it is possible that the first wife was a Morris, as was his second. It is to be noted that one of the descendants of what would seem to be the first wife was named John Morris Rose. It is also noted that the aforementioned Mary, daughter of Richard and Elizabeth, married Ezekiel Morris. However, there is a Richard Ro<u>ss</u> [sic?] who married 28 June 1792 to Elizabeth Fowler in Mason County, Kentucky, and this should be further investigated as a possibility.]

Richard Rose married second, 1 October 1821, Washington County, Indiana, (revolutionary file), Mary Morris, born ca 1785, Virginia, living in 1857 aged 72 in Hancock County, Illinois, (listed as aged 65, born Virginia from 1850 census), her parentage unknown. Her marriage given in *Hoosier Gene.*, Vol. 5 No. 6 -

Nov.-Dec. 1965 issue, shows the marriage as 10/12/1823.

YDNA testing puts the Richard<sup>1</sup> Rose family in Group O of the YDNA project. Stephen Rose, listed often as a son, has different DNA among descendants and is shown at the Rose Family Association website as



Group OX. Stephen could have been adopted or someone raised by the Richard Rose family; often this was done without formal adoption.

YDNA places the Revolutionary veteran Richard<sup>1</sup>Rose in the same group as Robert Rose of Montgomery County, Maryland and Washington D.C. and also with George Rose of Essex County, Virginia. The latter married Delphia Taylor and Dicey Marlow.

In the photo to the left, John tells us: "I believe that "Lee" is James Lee Rose 1902-1978. He was a son of William Maridy Rose 1873-1937 and Sarah Malvina Thomas 1880-1976. The man on the far right is reported to be William Maridy Rose 1873-1937. The man in the middle could either be Lilburn Faye Rose 1906-1986 or Carl R Rose 1909-1979. Just this week I learned that Lilburn Faye Rose b. 1906 probably had two sons and a daughter. The baby in the middle could be one of Faye's sons, but there was no identification on the photograph."


