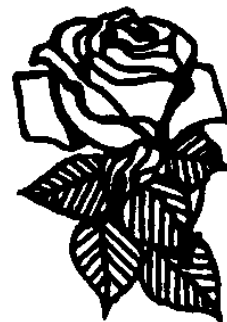
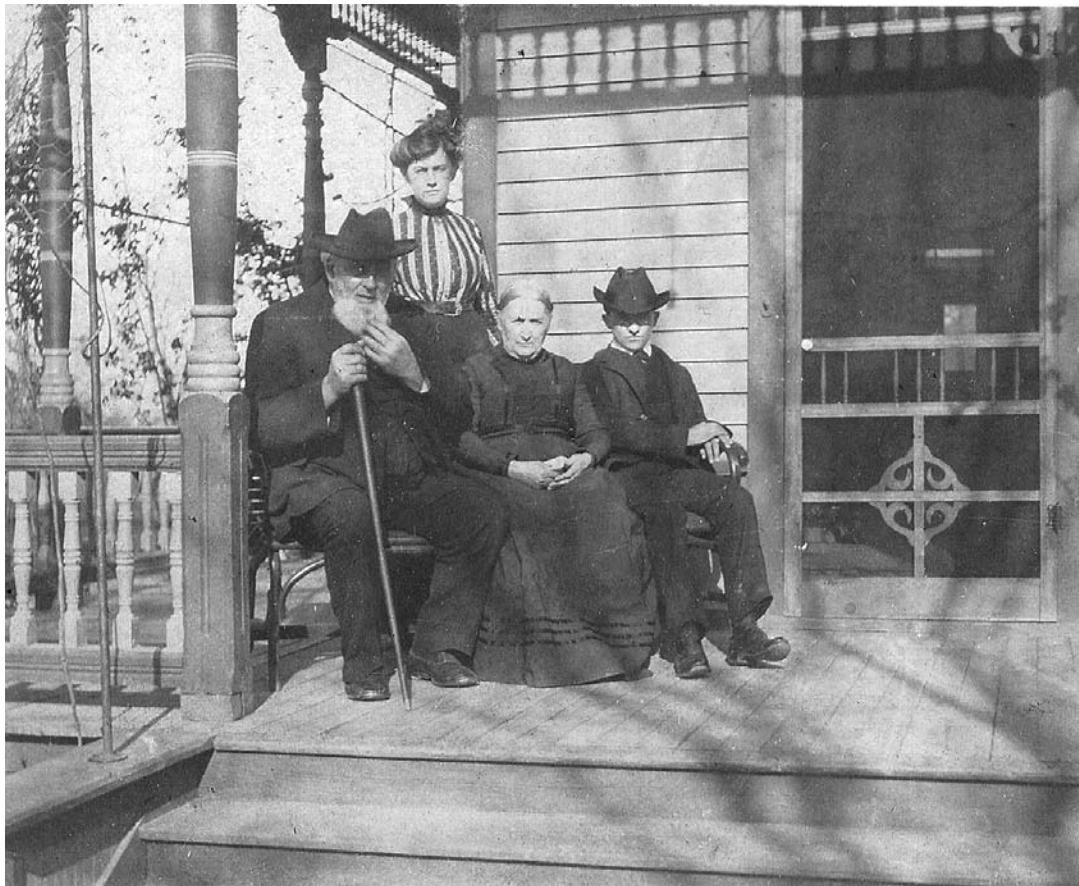

Francis M. "Frank" Rose (son of William W. Rose) was born ca. 1833. He is pictured with his wife Lavina (Leeper) Rose who he married 30 December 1855, possibly in Calhoun County, Illinois. She was born 15 February 1839 in Marion County, Indiana. The young woman is probably their daughter Mary. The boy is unknown. The photo was made at their home in Illinois.

Francis M.³ Rose (William W.², Francis M.¹), born ca 1833, Tennessee (census). The grandfather of Frank was Francis M. Rose of Giles County, Tennessee who previously left records in Knox County, Kentucky, and was evidently originally from North Carolina. DNA testing places this family in the Group C which places this family with the families of William and Martha Rose of York County, Virginia and Johnston/Wayne Counties, North Carolina, Thomas Rose of Sumter County, South Carolina, Samuel Rose of Madison County, Kentucky, and James Rose of Claiborne County, Tennessee, and Grundy County, Missouri.

JOHN ROSE. J. R. Helmsbold's (Unattached) Co.

Muster in roll, Capt. J. R. Helmsbold's (Unattached) Co., 6th and 23 July for 90 days. John Rose, Priv., 45 years old, in Altoona, mustered in by Cat. S. S. Child on July 6, 1863. (40 men). Muster-out roll of Capt. Helmsbold, Pa. Militia "called into service by the Governor" at Harrisburg. John Rose, Priv., 45 years old, June 23, Altoona, Pa., mustered into service at Camp Curtin, Pa. (1 officer and 18 men)

The above was supplied by Barbara Ackley. It is assumed these were notes taken from his Compiled Military Service File at the National Archives in Washington, D.C.

From the Lockbourne Cemetery, Hamilton twp., Franklin County, Ohio. Catharine Rose/Died/Jan 24, 1871/AGED/75? Y 9? M 6? D. The husband of Catharine Rose is uncertain. It is believed she was a Young before marriage. Among her children was a son Henry Rose born 20 July 1832, Pickaway County, Ohio (from his Civil War pension file) who married Mary Jane Straw.

From the Civil War pension file (published in RFB in 2002 and available at the National Archives) he married Mary Straw 8 September 1855 in Franklin County, Ohio by P. Harrison, JP. Included in the declaration was information from a family record in their Bible:

Will of PETER ROSE (a copy also filed in Will Book 1, p 173), of Northern Liberties, county of Philadelphia, yeoman, gives estate real and personal to be equally divided, to my sons Peter, John and William Rose and my daughter Elizabeth Miller and daughter Sarah House. Except silver watch to eldest son Peter Rose and to daughter Sarah House my 8 day clock. Appoints Peter Kline and Jacob Sullender both of Northern Liberties as executors. Dated: 28 Jan. 1804. Signed: Peter (his x mark) Rose. Wit.: Sam Macferran, John Graba?, Jacob Belsterling. Proved: Jan. 31, 1804.

INVENTORY: 29.19, dated Feb. 6, 1804, incl. "1 lott of German Books," etc. SETTLEMENT: 358.30. Signed: Jacob Sullender, Peter Kline, shows payment to Jacob Miller for his wife's share, and to Peter House for his wife's share, etc. Dated 1804.

Original File #204. 1841. Estate of PETER ROSE.

Will of PETER ROSE of Northern Liberties, yeoman, aged and infirm, gives to wife Elizabeth all estate real and personal, after her death, to three stepchildren, viz, Eliza Ash, Mary Shenk, and John Ash. To nephew William House my silver watch. Burial ground in Kensington to step children. Appoints wife executor and friend Jesse Owen. Dated: 12 Apr. 1838. Signed: Peter Rose. Wit.: Jno C. Nippes, John T.? Callahan. Proved: Nov. 17, 1841. RENUNCIATION of Elizabeth Rose dated 17 Nov. 1841 (she signed by x mark).

INVENTORY: Filed Nov. 19, 1841.

ACCOUNT: Signed by residuary devisees, Eliza (her x mark) Ash, John F. Ash, Mary (her x mark) Sheriff. Rec.: Aug. 28, 1847.

Will of Mary Rose

[This is the copied will in the Will Book, not the original will]: Will of MARY ROSE dated 20 Dec. 1854, of Tacony, county of Philadelphia, to daughter Caroline Elizabeth Rose, lot in Tacony No. 133, also a note, interest to be paid to my father William Maxwell (on note of Mathew Jordan); daughter is not yet 18. Also directs that daughter C. E. Rose to reside with father (William Maxwell). Dated 20 Dec. 1854. Signed: Mary Rose. Wit.: William Maxwell Sr., Jesse Duffield. Proved Jan. 15, 1855. Charles H. Rodes/Rhoads appointed executor.

Original File #200. 1797. Estate of JONATHAN ROSE.

INVENTORY: Jonathan Rose of Northern Liberties, Brick Layer, dec'd. Total L- 72.11.1 1/2. Appr. Sept. 21, 1797.

BOND: Ann Rose, widow of Jonathan Rose, dec'd, John Moore of Northern Liberties, Bricklayer, John Rose of sd Liberties, Brick layer, bond for Ann Rose as administratrix. Signed: Ann Rose, John Moore, John (his x mark) Rose. Bond dated 8 Nov. 1797. (This file mentions Book H p. 286.)

Some Elderly Rose

John Rose, resident of Santa Rosa, California, was born Feb. 15, 1942 and died Feb. 14, 2012. His wife



Ava Ogata Rose preceded him in death Apr. 12, 2011. They were both former employees of the *San Jose Mercury-News*.

He is survived by his brother Bill Rose. [From the *San Jose Mercury-News* of March 2012.]

Albert H. Rose, formerly for many years a well-known resident of the Cuba community, and a member of Bartle post, G. A. R., died Tuesday of last week in Rochester, of dropsy. Interment made in that city. He was about seventy-seven, born in Farmersville, Cattaraugus county, and enlisted in the Union Army. When he returned to his home in Franklinville he married Mary Cameron and moved to Ohio until about 20 years ago when he returned to New York. Of this marriage survives a daughter Ida Williams of Toledo, Ohio, and a son Joseph of Atlanta, Georgia. Soon after his return to New York Mr. Rose married a second wife, surviving, but no children. Buel Rose of Franklinville is a brother of the deceased, and he also leaves a half-brother and two half-sisters, Fred Rose of Arcade and Mrs. George Cole and Mrs. William Cooper, both of Rushford. Charles Rose of this village is a nephew. [Condensed from Allegany obituaries online, from a clipping dated 1915 posted by V. K. Bush.]

Lucius J. Rose: Mrs. M. E. Keller's brother Killed by Train in State of Iowa ... from a telegraph, Lucius J. Rose was killed by a fast train at his home in Olin, Iowa. He was nearly 52 and the third of five children, one of them died last spring. He leaves a wife, four daughters, four sons, and three sisters. [Condensed from an obituary posted by V. K. Bush,, name and date of newspaper unknown.]

Dickinson L. Rose, 82, services at the Kelly-Johnson-Boman mortuary. Burial was in Glenwood cemetery. He was a resident of Mankato since shortly after the Civil War. Among Roses from out of town attending the service were Mr. Rose's son and daughter-in-law, Mr. and Mrs. Reed Rose, and his grandson, Reed, Jr., of Madison, Wisc. [From the *Mankato Free Press* [Minn.] of Fri. July 28, 1939, sent by Cindy Torfin]

Ford Thomas Rose died October 12, 1996. He was born April 7, 1912 in Providence, Utah to Floyd Thomas Rose and Ofra Lillis Thorpe. He married Beulah Hinckley in the Salt Lake Temple June 30, 1938. They had five boys and five boys. He was preceded in death by his sister, Audine. Survived by his wife Beulah and his children: Pricilla Rose Crockett, Castro Valley, Calif.; Ford Thomas Rose II, Roy, Utah; Robert Floyd Rose, North Salt Lake, Utah; Kathleen Rose Jensen, Bountiful, Utah; Marie Rose George, Bountiful, Utah; Darlene Rose Rich, Green Bay, Wisc.; Jeanine Rose Dodge, Bennion, Utah; Kenneth Hinckley Rose, Wallace Hinckley Rose, and Lyman Hinckley Rose of Sandy, Utah, and grandchildren. Also survived by sister Ora Piper of Springville, Utah. Funeral from Larkin Mortuary, Salt Lake City and interment there in the Salt Lake City Cemetery. John N. Rose, Newark: After a long illness Mr. John N. Rose, a highly esteemed and well known hatter of Newark, died at his home there yesterday. Of late years he was connected with the press of Newark, and for many years took a very active part in democratic politics. He was seventy years of age.

Will Bk 4 pp. 439-440, will of Levi Rose of Deercreek twp., Pickaway Co. [File #O-2209], to my wife Catharine during her life the use of 2 acre lot where we live as her home with all furniture necessary for her comfort, also any of my personal property, also rents and profits from my 17 acre lot for her support for time she is my widow, pay balance that remains to my son James S. Rose, James to have occupancy of house and buildings on said 17 acre lot free of rent during her lifetime as long as she remains my widow; to Joseph Wardell husband of my daughter Mary lately decd, \$5.00; to Joseph J. Wardell, Frank Wardell, Mary Wardell (now married to William Smith), Levi Wardell and Hannah Wardell, children of Joseph Wardell and Mary Wardell my daughter now decd, each \$5.00; to my said son James S. Rose all my personal property not heretofore disposed of, also all furniture that remains at death of my wife; to said son James S. Rose all real estate, viz 2 acre lot I now reside and 17 acre tract known as "Halstead lot" etc. subject to bequests to my wife. Named as executors: David Terwilliger and my son James S. Rose. Signed: [blank] day of [blank] 1860./ Signed: Levi Rose. Wit.: James T. Wallace, Ezra Schryver. Ack.: 12 Oct. 1866.

Ed. note: It is of interest that several different Rose families seem to have passed through Pickaway County, Ohio at various times, and they were not all related.

Ed. note: Hershall submitted an account in the 1980s when we contemplated publishing a Heritage Book of Roses. This family is part of the William Rose of York County, Virginia, family and though they lived for a time in Surry County, Virginia, they are not related to the early Rose of Surry County, Virginia. Hershall Leon Settlemires was born 27 March 1926 in Wynne, Arkansas. On 17 May 1944, he entered the Navy and was stationed in the Philippines. After his discharge in 1946, he returned to his home in the Goose Pond area of Alcorn County, Mississippi. On 19 November 1947 Hershall married Charlotte Bennett who as born 6 January 1928 in Alcorn County where they made their home. Hershall worked for the Wurlitzer Company in Corinth, Mississippi and farmed. He had two sons: Roger Wayne and Kenneth Leon.

ther, migrated from Surry County, Virginia, to Johnston County, North Carolina, with his brother Benjamin Rose. James was fourteen years old. On 18 December 1798 James married Jerusha McGlawhon in Johnston County, North Carolina. James owned 713 acres of land at the time of his death in 1827. This land was located on the Great Branch of Mill Creek, near Smithfield, North Carolina.

After the death of James, Jerusha and her children moved to Hardeman County, Tennessee. Their children were: 1. Nancy b. 9 December 1799, m. Council Beard; 2. William b. 4 September 1801, m. --- Pace; 3. James b. 25 January 1804, m. Elizabeth Maxwell, 4. Benjamin F. b. 8 September 1805, m. Zelpha Coor; 5. Lucy b. 30 August 1807, m. Moses Bishop;

Benjamin F. Rose, the son of James and Jerusha (McLawn) Rose, married Zelphia Coor and was the father, among others, of William H. Rose who married Elizabeth Freeman. The latter couple had several children including a son Benjamin "Ben" Jefferson Rose.

Ben Rose married Sally Oldham on 9 October 1892 in Hardeman County, Tennessee. Among the children was Grace Odell Rose who was born 19 March 1902, married Noah Francis Settlemires. Grace and Noah had three children: Hershall Leon (submitter of this article), Frances, and Elbert

Norman was Patrick's great-uncle. Knowing that Patrick was interested in genealogy, Tillet's widow gave him a collection of "goodies" including photos. The one below was marked "FN



1823 Tillet" and therefore Patrick believes it is Tillet Rose who was born about that time.

Ed. note: Tillet Rose was a descendant of Samuel Rose of Estill and Madison Counties, Kentucky. He is believed to have died in 1898.

Tillet Rose married 23 February 1860, Jackson County, Kentucky (at the home of Samuel Rose) to Mary "Polly" Runnior/Runmore (marriage record needs to be rechecked on her surname). She was born ca 1826-1830, Kentucky, death unknown but living in 1880 census. [The following was submitted by Patrick W. Rose of Sunnyvale, California, a long-time member of the Rose Family Association. Patrick has worked diligently on his family for many years. Here he gives us some insight on his grandparents. This family is part of the DNA Group A.]

Edward Henry Rose was born in Beardstown, Cass County, Illinois on 29 Oct. 1887, He was born on a river boat sitting on the Illinois River. His mother was Melissa Cordelia Ackerman and his father was John Wesley Rose Jr. Ed had a twin brother whose name is unknown.

Edward's father offered the two boys to Allie Spangler, a local farmer's wife. Allie raised Edward as her own, but he was never adopted as far as your author knows. Edward was listed as "border" in the 1900 Federal Census for Philadelphia Precinct, Cass Co., Illinois. Your author has spent countless hours looking for any traces of Edward Rose's brother, without avail. I've searched the same birth date, but this date was created using a delayed record of birth, which may not be accurate.

Ed was working at a bank in Los Angeles as assistant cashier when he met his wife Pearl, who was working as a teller. [This statement leaves blank how Ed was trained as a cashier. My current knowledge is vacant on this issue.]

Pearl Iona Stevens was born in Beaver Falls, Beaver County, Pennsylvania on 26 June 1902. Her father, Thomas Judson Stevens was a plumber. Her mother was Minnie Elberta Wallace.

Pearl must have had piano lessons as a child because she was a skilled pianist and could sing like a bird. When we would visit their home during the holidays, Pearl would play the piano and sing for the family. It was a wonderful experience. After Pearl would entertain the family, the men would gather in the living room and tell stories (A custom I practice to this day—telling a special story at family gatherings.) I must admit I relish the children and grandchildren listening intently for the punch line.)

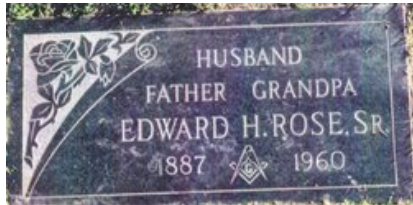
Your author is proven to be a descendant of Robert Rose¹ who arrived aboard the ship *Francis* from England

He died 24 December 1743 and had twelve children according this source (see p. 730). In the GOODRICH section of this book there is mention of Elizabeth Goodrich b. 2 November 1643 who married Daniel Rose in 1664.

A South Carolina family

WITH TIES TO SCOTLAND

John Rose first appears in South Carolina records in 1775, when he was appointed Clerk of the Court of Common Pleas in Beaufort. From his obituary, we know that he was only 23 years old at the time. This should guarantee an easy answer to his identity. It is inconceivable that any young man of that age, however gifted, obtained a position of this sort without political connections. In colonial South Carolina, that almost certainly translates to political patronage and family connections. We also know that

Beaufort.

Years of intermittent genealogical research have failed to prove his parntage, although we know much more about him than we do about most of his contemporaries. An earlier theory was that he was from the Aquilla and Hezekiah Rose line of the Beaufort area. However, the excellent work of Susan Shames of the Colonial Williamsburg Foundation has established that our John Rose is not from that family.

Rose married and had two children, Sarah Mary Rose (b. 1776) and John Simeon Rose (b 1778). His first wife died, and he remarried, to Mary Capers Ladson, widow of Benjamin Ladson, in about 1786. In 1795 he moved from the

led the singing and prayers at the Independent Congregational Church at Dorchester. Poyas described Rose in old age as “a man who, in his conversation, was easy and innocent, and whose whole life was exemplary.” She observed that Rose was close friends with Thomas Smith of Westoe Plantation and his sister Anne Smith Waring of Tranquil Hill Plantation.

Susan Shames took up her research and published her book *The Old Planation: The Artist Revealed*, because Colonial Williamsburg owns two paintings that she has conclusively identified with him. One of them, *The Old Plantation*, is arguably the most famous of all 18th century paintings of plantation slave life. It has been repro-

he had an 813 acre plantation on the Coosaw River in Prince William Parish, owned numerous slaves, and occupied a social position sufficient to be designated a member of the vestry and a warden of St. Helena Parish in

Beaufort area to Dorchester South Carolina. In 1820, he died in a fall from his horse in Charleston.

Rose was described in memoirs of her early life by Elizabeth Poyas. She said that he was “an accomplished old Christian man” who

duced many times in books on colonial plantations and slavery and is also reproduced on-line at Wikipedia. It is unique for its time as a sympathetic and respectful portrayal of slaves as individuals engaged in their own lives, rather than serving others. The painting

documents the survival of African musical instruments and dance in South Carolina in the late 1700's. Another painting conclusively identified by Shames as the work of John Rose is of a female slave and is labeled "Miss Breme Jones." That painting is inscribed with lines from Book VIII of Milton's *Paradise Lost*:

"Grave in her steps
Heaven in her eyes
And all her movement
Dignity and Love."

So, the puzzle was difficult from the first and has become even more so. How did this gifted 23-year-old become Clerk of the Court of Common Pleas in Beaufort, while owning a plantation that came into his hands by unknown means? How could someone so politically connected, well-educated (multi-lingual), musically trained (said to have played the organ in church and at his own organ at home) and artistically trained be so difficult to associate with a known family in Lowcountry South Carolina? Contemporaries commented that few of his era were like him in his artistry or his character. His associates were from the most distinguished and well-educated early families of the region. His origin should be obvious, but isn't.

Several Rose families in the Lowcountry have been eliminated from consideration, and another (Accabee Plantation) is very unlikely. A child of the Accabee family is documented in the St. Andrews Parish Register and was born within ten months of our John Rose, who is not documented in the parish register. Further, Accabee was a close-knit family, and there is no evidence of contact between John Rose and individuals in that family and no mention of him in their wills.

What remains is the large number of people in the 18th century

Lowcountry from the Rose family of Kilravock. They only rarely directly associated with one another, having arrived and established their residences independently. Several of them provide more grounds for optimism than the others. There is a William Rose who wrote his will in Prince William Parish [where our John Rose owned a plantation that he might have inherited, no evidence that he purchased it himself] in 1755, probated in 1756, leaving his estate to his son William. The published transcription of the will is in error, but the handwritten version shows that he leaves his estate to a son, William, "now living in Rosshire [the middle "s" is a long-tailed 18th century "s"] and Parish hag [or Parishag] and in the care of Mr. John Boffoon." Ross-shire was the home, along with Nairnshire, of the Kilravock Roses. The only "Parishag" that we have found is "Parishagh" in County Antrim, Ireland. One document notes that in the early 1700's the Earl of Antrim gave property from his barony to various Scottish families, unspecified. It is one possibility for the location in the will, but no more than a possibility. No other Roses are mentioned in William Rose's will, even though they were present in the SC Lowcountry.

A Dr. William Rose was also in Prince William's Parish, having married Lucia Wilson, the wealthy widow of William Bellinger. He was for a while in partnership with Dr. Alexander Garden, the famous botanist from Scotland. After Dr. Rose and his two young daughters died in about 1764 John Rose of Hobcaw Point (proven member of the Clava Roses) and Alexander Rose of Charleston (proven member of the Kilravock Rose family, born at the castle in 1731) intervened to control his estate on behalf of closer kin in Scotland. They succeeded, and heirs in Scotland inherited from Dr. William Rose's deceased daughters the land that had come

to their mother through her first marriage to William Bellinger. Other than intervening in this estate, the Roses of Kilravock in the South Carolina Lowcountry seem to have had little or nothing to do with one another.

John Rose of Beaufort and Dorchester was better educated than any but the most affluent of Lowcountry planters. It is very possible that he was from the Kilravock family, and perhaps his early residence in Beaufort and his plantation in nearby Prince William Parish were the product of inheritance from one of the William Rose's of Kilravock who lived in that Parish. He does not seem to have been the immediate heir of either of them, but a death in the family could have left John Rose the heir who would take possession of the Prince William's Parish property owned by one of these individuals. However, this remains unproven and may eventually crumble as other ideas have. The search for a proven origin for this remarkable man continues.

ROSE, George Basil, lawyer, was born at Batesville, Ark., July 10, 1860, third son of Judge U. M. and Margaret T. (Gibbs) Rose. George B. Rose received a preparatory education in the public schools of Little Rock, and subsequently took a course at St. John's College, Little Rock, graduating in the class of 1875. He studied law in the office of his father, and was admitted to the bar in 1879. He soon began the practice of law at St. Louis, Mo., where he remained a year or more. Returning to Little Rock he formed a partnership with his father, under the style of U. M. & G. B. Rose, which continued about ten years, after which the firm became Rose, Hemingway & Rose, one of the most eminent and prosperous law firms of the Southwest, having a large docket of general and corporation practice. Mr. Rose is a persistent and laborious student, and devotes a great deal of time to the study and preparation of his cases. He is a student of art and literature, and speaks French and Italian fluently. He inherits much of the studious nature of his father, and is fond of research in fields not bounded by common law, and not usually sought by practitioners of his age. He is a lover of verse and has written numerous poems, being author of several volumes published at his own expense for private distribution. His facilities for both legal and literary research are of a high order, and he has made use of these advantages. His legal papers are prepared with great care and exactness, and his speeches are terse, logical and strongly argumentative, without waste of language. He is fond of travel, and at times indulges this predilection in wanderings in his own country, the British Isles and the continent of Europe. He is a lover of the fine arts, and has procured, by purchase in Europe, several of the most valuable paintings to be seen in his state. In the flush of a strong and prosperous manhood the future is full of bright promises to him. Mr. Rose was married, in Little Rock, May 2, 1882, to Marion, eldest daughter of E. W. Kimball, one of the most prominent lawyers of Arkansas, a native of New Hampshire, and a lineal descendant of one of the Kimball brothers who came to America from Boston, England, with the Kimball expeditions in 1634. She is an accomplished lady, educated at Wellesley College, Massachusetts. One son and one daughter were born of this union. The daughter died in infancy, the son is still under the paternal roof.

[Editors note: The following was supplied by member Sara Byrnes. Lyman Rose, father of Corwin F. Rose, was son of Lyman B.⁴, Rufus³, Daniel⁴, ³, ², Robert¹. Lyman Rose married Caroline Throop. Their son Corwin Rose married Susan Amelia Hutchinson on 24 December 1871. Sarah Byrnes has Susan's diary from 1870. She thinks Corwin traveled back and forth from Ohio to New York for work. Her account follows.]

When I was a young girl our mother often took my sister Betsy and I to up-state New York to visit our Grandmother or Nana (Margarita D. North). She would leave us for a couple of weeks. Nana would give us a diary to read. We weren't much interested then. The diary was written in 1870 by Susan Amelia Hutchinson. Susan taught school in Unadilla, Otsego, New York area. She would farm out during the week in the area of the school house, working for the family she was staying with. Then her father would pick her up on Friday. Susan had her eye on Corwin in that diary. She would write, saw him today, had a nice visit or didn't see him was much disappointed. She would practice writing his name. Corwin was in the Civil War although I haven't found out much about his service except that he may have been in West Virginia and Virginia. In 1871 Susan married Corwin F. Rose. Their daughter Lucy Delilah Rose married Fred A. North. Lucie died at a young age of typhoid fever. Nana was raised by Susan. Margarita D. North married Ivan H. Thompson. My mother Rosaline North Thompson was born in 1913 in Albany, Albany, NY. Ivan disappeared when my mother was very young. Susan helped to raise Rosalinde. Rosalinde North Thompson met Carroll Vaughn when they were in High School together. They eloped and the family had the marriage annulled. I don't know by who's influence. My oldest brother Richard Carroll Vaughn was born. Susan Amelia Hutchinson helped raise Richard. My mother met my father Robert James Byrne in Norwich, Chenango, New York, they had six children together. I was born in Richmond, Virginia. I lost my father when I was 8 years old. The diary came into my hands around 1986. The pages were old and fading. I went out and purchased a new one and transcribed the pages using a magnifying glass. (That was before home computers.) That is what got me started on researching my family tree. I live in Annapolis, Anne Arundel, Maryland. I retired in 2001 from the State of Maryland Comptrollers office after 39 years. I returned to my maiden name after divorce. I raised two sons and have four grandchildren. My hobbies are basket weaving and re-caning old chairs. I also love to knit but my new passion is looking into the past. There is so much more available to us today. Sara E. Byrne, 18 March 2013"
