

Mar. 1775. INVENTORY: 24 Mar. 1775. Total L-132.9.93. Ret'd 6 Feb. 1776.

Will of Abigail Rose of town of Woodbury, co. of Litchfield, whole estate to my only son Samuel Rose. If he should die before he comes of age, whole of estate equally divided between my three brothers Israel, Samuel and Daniel Linley. Appoint Mr. James Frisby my neighbor to be sole executor. Dated: 7 Sept. 1774. Signed: Abigail Rose. wit .: Joseph? R.? Bellamy, Jane Kasson, Abigail Weller. Proved: Mar. 22, 1775 by Jane Kasson and Abigail Weller and 3 Apr. 1775 by Joseph Bellamy.

### Genesee County, New York

Copied at the courthouse.

Ann Rose, Adm. Bk 5 p 446 Ann Rose, died intestate, petition of William S. Rose of Town of Le-Roy, he is son of Ann Rose, who died 13 Apr. 1884 at LeRoy, and she left: William S. Rose, her son, your petitioner, of LeRoy, Genesee Co., who petitions for letters to be granted to him and Henry Steuben. Dated 21 Apr. 1884. Signed: William S. Rose.

Adm. Bk 6 p. 60, petition of Henry Steuben in above estate, of Town of LeRoy, a creditor of Ann Rose, who died 1 Apr. 1884 at LeRoy and left no kindred entitled to her estate. Dated: 25 Feb. 1885.

Note: It is noted that there appears to be a discrepancy in the above. William S. Rose petitioned that he was her son, and a year later Henry Steuben as a creditor petitioned stating she left no kindred. It may be that William S. Rose died in the interim. The original packet shold be examined for further clues, and the two petitions re-read carefully.



The first of the Rose children to tie the nuptial knot was Ferrill Rose who married his wife Edna Feb. 67, 1937 in Kansas City. The couple live in Florence, Mo. Five months later, June 12, 1937, Gerry Rose married Rev. Arthur Lickey in Liberty, Mo. Edwin Rose and

his wife Joyce were married Mar. 23, 1943 in Kansas City where they currently live. The only living Rose sibling not married 50 years is Martha Rose Shrimpton of Kansas City whose husband died 30 years ago. ## Robert Rose of Branford descendant of NE family

Rose Klix #2840R02 sent along (with permission) some items sent to her by Sterling Clack. These concern family #509 in Christine Rose's *Descendants of Robert Rose of Branford and Wethersfield, Connecticut* (San Jose, Calif.: Rose Family Assn., 1983) p. 377. They are two burial permits:

Norman Rose d. Feb. 17, 1929, aged 84y 3m 9d, resident of No. Sunderland, Mass., permit issued to Leon E. Rose of No. Sunderland. Signed: William E. Clark.

The other is for his known son, Leon Edward Rose who died Jan. 6, 1955, permit issued to Roy D. McCarthy. The permit was for the removal from Greenfield (Mass.) to No. Sunderland and was signed by Marion Lyman, Burial Agent.

Thanks to Rose Klix for watching for and finding items that add to the book on this family! She has researched exhaustively in trying to establish the facts of her own descent to this early New England family.

### "Pete" Rose, the Baseball Player

The Association has often been asked to which family Pete Rose was connected. Letters to him in the 1980s were unanswered, but based on the obituary of his father, and other information and combining that with the 1910 and 1920 census of Hamilton County, Ohio, in Cincinnati, we have concluded that his father was named Harry "Pete." Pete is the Harry Rose aged 7 listed as step-son in the home of Harry Sams age 34 born Ohio and his wife Eva Sams age 29. In the 1910 census of Hamilton County, Pete's father Harry is listed as age 24, born Ohio, in the home of Henry Rose Sr. who was 54 born Germany. Henry immigrated in 1887 and was naturalized.

Pete Rose had a brother William Rose, and a half-sister Eveline Rose, The latter, we are told, married a Truss.

## My Rose Family: Eusebius Milton Rose

### BY IRMA CLOSE PROVINCE

This account was submitted in the 1980s by Irma Close Province, a member of the Rose Family Association, in a Rose Heritage project. Her ancestor Eusebius Rose was a descendant of Ezekiel Rose of Washington County, Pennsylvania, and Roseville, Ohio. He was a son of Alvah Buckingham<sup>3</sup> Rose (Ezekiel<sup>2</sup>. Ezekiel<sup>1</sup>. The photo that Irma submitted was a very dark photocopy but is included here to give the family an idea of what these family members looked like. Irma's account:

Eusebius Milton Rose, youngest son of Alvah B. and Margaret Ann Stewart Rose, was born 9 February 1857, near Riverside, Iowa. His father, Alvah B., was born 7 December 1816 according to family records, and was a son of Ezekiel Rose Jr. and his wife Sarah Thrap. Alvah B. and Sarah were married in Zanesville, Ohio on 15 September 1818, moving to Washington County, Iowa, in 1839. their children, in birth order, were: Eliza Cole Hardy, John (died young), Hannah E. Glasgow, Columbus J., Joseph R., John Abram, Euphrates Alvah, Mary Ellen (Ellia) Maurer and Eusebius Milton.

Eusebius grew to manhood on his father's Iowa farm and on 21 August 1877 he married to Susan C. Whittington, daughter of Henry C. and Margaret (Boyer) Whittington. They continued to live in Washington and Shelby counties in Iowa until the fall of 1887, when they moved to Rush County, Kansas. Together they faced the hardships of pioneer life with great courage and faith in God. To this union seven children were born: Stewart Irven, Carl Lester, Lucina Margaret Close, Alvah B., Herby E. (died in infancy), Harold Raymond "Harley", and Menetta Bessie Shepherd.

For many years they made their home near Hargrave, Kansas. One of the first things Eusebius did after coming to Rush County was to help organize a Methodist class at the Hillsdale school house under the

leadership of Rev. Bell. Later this class disbanded and he and his family became members of the Friends Church which had been organized in the Sand Creek Community.

In the summer of 1910 they moved to a new home near McCracken, Kansas, and it was just after moving threre that Susan, his devoted wife, became ill and died on 26 August 1910.

On 10 April 1919 Eusebius was married to Henrietta Palmer, who was a loyal companion through the years. "Sebe', as he was fondly known to his friends and neighbors, was always ready to help anyone in need and was never happier than when some of his eighteen grandchildren gathered around him to hear his stories of early days in Iowa.

After moving to McCracken he united with the Methodist Church

there and remained a faithful member until his death on 8 April 1941.

Following a stroke he was bedridden for the last two years of his life, requiring constant care by his family, but his patience and cheerfulness during that time proved to be outstanding traits of his character.

### Alexander Rose Family of Person County, North Carolina

The late Dr. Ben Lacy Rose compiled and published a genealogy on his Alexander Rose family. Among the papers Ben later sent to the Rose Family Association were several items regarding William Cumming Rose of this family. William C. had an illustrous career and contributed greatly to his field. Many articles, awards, etc. were written and presented.

The following obituary was publishing in *The Champaign Urbana News Gazette* on Sunday, September 29, 1985.

The description of someone as "a scholar and a gentleman" is often used, only sometimes meant and rarely deserved.

For William Rose, it was both common and appropriate.

An internationally recognized pioneer in biochemistry, he died Wednesday in Urbana at the age of 98.

From 1922 until his retirement in 1955, Rose taught at the University of Illinois. During that period, his research led to breakthroughs in the study of amino acids. It was his work that fostered the discovery of threonine, an amino acid indispensable in animal and human diets, and led to the establishment of quantitative amino acid requirements for nitrogen balance in human adults.

In 1966, that work was recognized when President Lyndon Johnson awarded him, the prestigious National Medal of Science.

Herbert Carter, then head of the UI department of chemistry and chemical engineering, was among

those offering praise.

Mr. Rose, he said, had "nearly single-handedly" started the research that later became the basis for studies dealing with the worldwide problem of protein nutrition. Nearly 20 years later, the current head of the UI's biochemistry department, Lowell Hager, agreed that Rose's contributions endure as having "laid the foundation for all modern nutritional studies relating to proteins and amino acids."

Among Rose's other honors, a seminar room at the UI and a national lectureship in biochemistry bear his name. He held honorary degrees from Yale, the University of Chicago, the UI and Davidson College.

But those who knew Will Rose are as quick to note his manner as his scholarship. The word "gentleman" is used often and sincerely.

Larry Faulkner, the head of the UI's department of chemistry, said that describing William Rose as a gentleman and a scholar was no overstatement.

"It characterized him better than anyone I've ever met," Faulkner said.

Will Bk 6 p. 145: Ann Rose and Wyatt Hawkins, bondsmen, 27 Aug. 1792, for Ann Rose as administrator of estate of Richard Parham, decd. Signed: Ann (her x mark) Rose, Wyatt Hawkins. Aug. Court 1792.

Will Bk 7 pp. 167-168: An Inventory of the Estate of Anne Rose decd taken by Sterling Clack this 26 Aug. 1794 [list follows]. Signed: Sterling Clack. Ret'd. Aug. Court 1794 by Sterling Clack, adm.

Will Bk 7 pp. 170-171: Sterling Clack and William Smith are bound unto William Johnson, Chairman of the County Court, for Sterling Clack, administrator of estate of Ann Rose, 20 Aug. 1794. Signed: Sterling Clack, William (his x mark) Smith. Wit.: M. Duke Johnson, C.C.

### Frank E. Rose Alias Frank E. Smith Regular Army: Indian War Pension

Ed. Note: Some of these files are in (or were) in custody of the Veterans Administration and were not available at the National Archives. That is true of many with the file designations similar to the above. Editor obtained a copy of this file in 1986 from the Veterans Administration Regional Office in San Francisco, Calif., who was in custody of this when inquiry was made. Following is an abstract of the file.

FRANK EDWARD ROSE, aka FRANK E. SMITH, Co. K, U.S. Art., filed 1933, Appl. 31.387; Mass. Cert. A-12-19-33. File XC2635956.

Declaration for Survivor's Pension, Indian Wars, act of March 3, 1927: Bristol Co., Mass., 16 Feb. 1933, Frank Edward Rose, aged 68, b. Oct. 30, 1864 in New Bedford, Mass., that he enlisted July 28, 1876 at New York, N.Y. as Frank E. Smith in Battery D, Fourth U.S. Artillery, and was honorably discharged July 27, 1881 having served in the campaign against Indians in the State of Georgia. Pers. Desc.: 5 8", ruddy compl., brown eyes, brown hair, his occupation was as carpenter, since leaving service he has resided at New Bedford, Mass. He had partially loss of sight in right eye, vision defective left eye, defective hearing, foot trouble. He did not serve in the military between Apr. 6, 1917 and July 2, 1921. Signed: Frank Edward Rose, 31 Margin St., New Bedford, Mass. Wit.: Walter Rawcliffe? And John W. Devin, both of New Bedford. Added: Was he previously married, yes, to Sarah Morrison, married May 25, 1886, died Mar. 4, 1911 at New Bedford, Mass. Married Ebba Johnson June 13, 1913, divorced Dec. 31, 1931 at Providence, R.I. Living children: Frank Rose b.

Sept. 12, 1888; Mary Devlin b. May 30, 1891; Sarah Gellette b. June 16, 1889; Stella Rose b. Apr. 2, 1867

Regular Army: Adj. Gen. Office, Feb. 15, 1934, directed to V.A., Washington D.C. Claim S.O. 1,731,387, Frank E. Smith, b. New Bedford, Mass., a painter, age 22 yr., dark eyes, black hair, sallow compl., 5' 8", enl. July 24, 1885, Batty D 4th Reg. U.S. Art., disch. July 25, 1890 at exp. "No record is found of any service in the zone of, or in connection with, any active Indian hospitalities." Was single at enl., married man at discharge. Next of kin not of record.

War Dept.: Mar. 17, 1933, no record of enlistment has been found in Regular Army for man of name of Frank E. Rose during July 1876, nor found on the muster-rolls of Batty. D, 4th Reg., U.S. Art. During the period in question.

James A. Murphy, 66, res. New Bedford, Mass., has known him for 62 years, etc. Signed 6 May 1933, Bristol Co., Mass.

Note: It appears that there were two Frank E. Smith who served in this time period. In a letter March 28, 1934 from the House of Prpr. To Frank Edward Rose alias Frank E. Smith, it is stated that "the vetern's pension was discontinued" because records of the War Dept. showed there were two veterans by that name who served in Batty D 4th U.S. Art. And that one enl. July 28, 1866 and disch. July 27, 1881 and the other enlistment July 24, 1885 and disch July 25, 1890. "It appears that one Frank E.Smith of Alameda, California" filed claim Mar. 15, 1917 and was allowed pension in connection with Indian hostilities in 1876. Evidence shows the present application of Frank E. Rose alias Frank E. Smith was the one who enl. July 1885 and is "without title to pension."

By letter Feb. 27, 1934, Frank E. Rose of 31 Margin St., New Bedford, Mass. Was informed that his record had been confused in the War Dept. and that he had erroneously been receiving a monthly pension. Their records also disclosed there "is no record of any service which you rendered in the zone of in in con---? With any active Indian hostilities. You are, therefore, not --- to the benefit which you received and it will be discontinued at once." Signed by Veteran's Claims Service.

[Note: He is likely the Frank E. Rose in 1930 Pawtucket, Providence Co., R.I., b. Mass., parents b. Portugal. Wife Elizabeth E. listed with him. He was divorced the following year in R.I. according to affidavit.]

"While visiting my first cousin (Kai Lewis Brouchoud) ... she showed me an antique oil portrait that came out of our grandparents' home in Racine after they had passed away. The mystery has been in trying to identify the person in the portrait, but we believe it to be one of our ancestors. It hung



in a prominent place in the Racine home for as long as anyone can remember. Looking at the portrait of the first Robert Selden Rose, I can see facial similarities that would make me think this may be one of the Roses." Kai says there is nothing written on the back of the painting but it was framed by the Thurber Fine Arts company in Chicago, which I believe did framing between the years 1880 and

The ledgers of payments are from Microfilm publicationT-718 Roll 1 Vol. A, Act of 1818, 818-32, Ledgers, but those include all payments made. The Final Payment of Pension files are only available if there was an outstanding sum due the pensioner and someone claimed it. These are only for the Revolutionary War. These claims were made by an agent for the estate (executor, administrator, etc.) or by heirs of a deceased pensioner. Only the ledgers are microfilmed; the files themselves must be requested on NATF 85 or if at the Archives personally, use their in-house form. The following file was personally examined at the National Archives by editor. To request a file provide the name of the pensioner (usually the husband or spouse), the agency from which the payment was made (in this case Richmond), and a date or approximate date of death. This is because the files are organized in that manner. Note also that there could be two files; one for the husband and one for the wife. Or, only one file which could be for either the husband or the wife. Or, if no one filed such a claim, there will be be no file.]

There was also a Walter Rose in Pensacola in 1874 who built an ice house on the waterfront, and a A. J. Rose who was an attorney in the 1890s. Their court case index shows an F. P. Rose who was in the fishing business with a J. R. Saunders in the early 1900s.

#### FROM INFORMATION SUBMITTED BY ARLO AND JEAN (ROSE) BAUMGARN

Arlo and Jean are very interested in Jean's Rose family. She is a descendant of George Melville Rose, a son of Aaron and his first wife Theresa "Therzy" (Young) Rose. Though it was known that there was some sort of connection between George M. Rose and Aaron Rose, it wasn't clear whether they were father and son. However, Arlo and Jean found at the National Archives the Recruit Declaration for 1861 in the Civil War in which George M. Rose signed, and Thersey (her x mark) Rose signed for consent of a minor. which provides some very good evidence.

This family descends from Phillip Rose of Franklin County, Ohio. Many will recall this family has been of particular interest because Phillip's daughter Sarah married a Abraham Lacy Rose. Jean's ancestor Aaron Rose was a son of Philip, and brother of Sarah (Rose) Rose. Y-DNA testing puts Phillip Rose in Group Y, while his son-in-law Abraham Lacy Rose is in Group K (the latter related to Long Island Roses).

### Joel Beverly Rose, Dubois County, Indiana and Kentucky CONNECTED TO EDITOR'S FAMILY OF BENNET ROSE OF KING GEORGE COUNTY, VIRGINIA AND NORTH

CAROLINA

The following was extracted from a lengthy account sent by Carol Horne who tells us that this account was prepared by her great aunt Helen Rose. DNA testing indicates that this family is in Group L which is not surprising since they carry the name of Bennet in their family. Associate editor Seymour T. Rose descends from Bennet Rose of King George and Culpepper Counties, Virginia who later moved to Surry/Wilkes County area of North Carolina. Joel Beverly Rose.

Lengthy notes "Historical Notes on Dubois County 'Indiana" ... The members of the Rose family, American settlers in the western part of Madison township, were for half a century a beacon light of intellectual activity ,... By request Miss Helen Rose has kindly furnished these Historical Notes with the following history of the Rose family, and EARLY LIFE IN MADISON TOWNSHIP:

"Mary Ann Nicholson, eldest daughter of Richard and Susan Stover Nicholson, was born on a farm in the extreme northwest corner of Clarke County, Indiana, Jan. 10, 1843. She was the third child in a family of thirteen. Her grandfather's family had moved to Indiana from the Allegheny Mountain region during the thirties. They were a part of the tide of western emigration. The elder Nicholson and his sons came to Indiana in good financial circumstances. Richard Nicholson and his family came to Hillman, Dubois County about 1855, where my mother attended district school until fifteen years of age, when her teacher told her she was able to make a license to teach. He presented her an English grammar, edited by Noble Butler, as a reward for excellent scholarship. However, she did not become a teacher, as women were not yet engaged in that profession in Dubois County, but, instead, assisted in the performance of the numerous household duties entailed by the needs of a large family. Spinning, dyeing and weaving, and sewing were domestic arts in which she attained unusual skill. She took an active part in church and social affairs of the time and place.

"One event when she was scarcely eighteen, her 'knight' in the person of my father "came riding by" and asked for lodging for the night. The celerity with which she prepared the evening meal attracted his attention as readily as her bright, dark eyes, raven black hair and fine complexion. The result was that after a courtship of two years, they were married Dec. 23, 1862. They became the parents of six children, Helen, Mary B. (Mrs. Mollie B. Cooper), Edith (Mrs. Edith R. Hostetter), Charles B., Susan (who died in infancy) and Maye (Mrs. Maye R. Green). My mother died Dec. 22, 1919. The remains of both mother and father rest in Shiloh Cemetery.

"Joel Beverly Rose was born in Southern Kentucky, July 11, 1831, and died at his home in Madison Township, Dubois County, Indiana, May 18th, 1897. He was the son of Walker and Edith Kemper Rose. He was the third of seven children. His paternal grandfather, Wm. Bennett Rose, had emigrated from Culpepper County, Virginia, to Kentucky. His father was a tanner by trade and his mother the daughter of a wealthy Kentucky land owner, who voluntarily freed his slaves several years before the beginning of the Civil War.

"Joel attended school in a pioneer log schoolhouse with a huge fireplace in one end of the room, uncomfortable backless hewn log seats in the center, a hewn log shelf extending along one side which served as a writing desk during the day and upon which books were stored when not in use. The chief materials of instruction were a reader, a spelling book, an arithmetic, a copy book and a goose quill pen, and presiding over all a stern master who wielded his beach rod without discrimination. On account of the death of his father Joel was compelled to leave school at the age of thirteen and assist his mother and older brother John in earning a living for the large family. At the age of twenty he became a partner with his brother-in-law, Amos Dye, in the live stock trade, which consisted of buying and selling horses, sheep and cattle, While engaged in this business, he made several steamboat trips to New Orleans. In the meantime, his mother had received a considerable sum as her inheritance from her father's estate, and the family had moved to the more progressive region further north ... according to the Dubois County official records concerning the transfer of real estate, in 1854, Dye and Rose purchased from Samuel Postlethwait, a farm of two hundred acres west of Ireland, the same lying in sections eighteen and nineteen. The next year they sold this to William Mahan and returned to Kentucky where the Dye family had continued their residence. About 1857, Joel B. Rose and his brother-in-law dissolved partnership, the latter with his wife, Aunt Mary, moving to Texas. The older brother, John, had married and gone to Arkansas to establish a home for his coming Con't next page

family. Two brothers, Oscar and Alonzo had died while the family lived in Southern Kentucky. The remainder of the family, consisting of Joel B., his mother, a younger brother, Albert, and a young sister Melvina, came to Dubois County. In 1860, Joel B. and Albert purchased seventy-five acres near Hillham, Columbia Township, from William M. and Mary A. Cave ...

Ed. note: The following has always intrigued us, because of the name of Bennett Rose, the same as editor's ancestor. Now it would appear very likely that the following is connected in some manner to the family of Joel Beverly Rose of this present article.

Acts of the General Assembly of the commonwealth of Kentucky 1841-1842

p. 146: Chapter 116. AN ACT for the benefit of the heirs of Bennett Rose, deceased.

SEC. 1. Be it enacted by the General Assembly of the Commonwealth of Kentucky, That it shall be lawful for the guardian of Eliza Jane Rose, William Rose, Winston Rose, Bennett Rose, John Rose, Elizabeth Rose, and Mary J. Rose, children and heirs at law of Bennett Rose, deceased, to file a bill or petition in the Casey Circuit Court, praying for the sale of a tract of land, in the county of Barren, which belonged to said Bennett Rose at his death; and the Judge of said court is directed to decree the sale of said land whenever the guardian shall manifest the propriety and expediency of so doing, in the manner prescribed by existing laws: Provided, however, that the Judge of said court shall be regulated in his action on said bill or petition, by the laws now in force and the rules of chancery practice.

Sec. 2. That it shall be lawful for the Judge of said court, if to him it shall appear most beneficial to the interest of the heirs of said Bennett Rose, deceased, to appoint some fit and proper person as Curator for said heirs, and to him said Judge shall confide, under the supervision and control of the court, the power and authority to select, contract for, and purchase, in the name and in behalf of the heirs, some suitable tract of land in the county of Casey: Provided, said Curator shall not undertake or contract to pay therefor, a greater sum of money than that realized by the sale of the tract of land in the county of Barren, and the Judge of said court is hereby invested with full and ample power and authority to make all such rules and decrees as to him may seem right and necessary to effectuate the object and intent of this act.

Approved, February 1, 1842.
