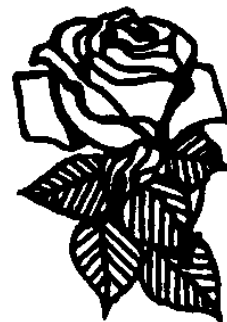

Edward Earl Rose and Nelle (Tarleton) Rose of San Jose, California

Editor Seymour Tarleton Rose's great-grandfather William Jefferson⁵ Rose (Bennet⁴, Abner³, Bennet², John¹ of King George and Stafford Counties, Virginia) was born 19 March 1831 in Lauderdale County, Alabama. About 1852 he left Alabama and went to Madison County, Arkansas evidently to join or accompany a Burney cousin. He met and married there on 3 August 1854 Margaret Elizabeth Gibson who was born 7 December 1838, a daughter of Joseph and Mary Elizabeth (Mashburn) Gibson.

Two years later, in 1856, this couple, with a small child, joined a wagon train, left Arkansas, and went overland to California settling in Fiddletown. The reason: the same as so many others – William panned for gold throughout the Sierras and is recorded in census up and down the range of mountains

On a gold digging trip with his older sons, William became ill – it is believed with pneumonia. His wife was summoned and rode many miles by horseback to reach him but he died 21 June 1879 in

Tulare County, California. He had not reached home and was buried in what is now Kings Canyon National Forest in an unmarked grave marked only with a mound of stones. An obituary confirms the details. The mound of stones was washed away in a severe storm in the 1950s so the exact spot can no longer be located though photos exist.

After William's death Margaret married second, as his second wife, on 17 December 1885, in Monterey County, California, George Washington Thompson previously of Paris, Missouri. He died 24 June 1927, in Alameda, California, buried in Oak Hill Memorial Park, San Jose. Margaret died 26 June 1931 in Alameda, California, and is also buried in Oak Hill Memorial Park.

William and Margaret had several children: Nancy Elizabeth b. 1855 who d. the first winter in California, infant son b. 1857 d.y., John Alexander b. 1858; Thomas Bennet b. 1861; William Lee b. 1863; Samuel Smith b. 1865; Mary Emaline b. 1867; Martha Elizabeth b. 1868; Joseph Franklin b. 1873 and the youngest, Edward Earl b. 1875 (editor's grandfather). *Con't p. 5872*

Dear Readers,

We are constantly amazed at what is now available on the Internet. Editor has been using digitized images of many deeds, probates etc. for many counties. If you haven't used it yet, do try www.familysearch.com. You must sign up but it is free. It takes a bit to get used to how to search on it, but persist. In using a location go to catalog and then frame your search such as:

UNITED STATES, MASSACHUSETTS, HAMPDEN COUNTY

The above search would take you to a listing of what is available. Choose an item, and again click on the link. Keep doing that until you get down to what you would like to view. Don't stop too soon! If you get a screen with a listing showed "Add" to the right of each item, be sure to pick the one you want and again click. That will take you to a screen that should indicate with a camera icon to the right if it have been digitized and is available to view, or if it is in some other form such as film. How nice, for instance, to be able to read a deed by enlarging it on your screen, printing it, etc.!

There are other websites with digitized images such as ancestry.com, americanancestors.com. Those do have subscription prices but when it is considered that it is saving many trips to the localities where the records are located, you may find them more than worthwhile.

We have often asked members to prepare 1-2 pages about their parents or grandparents and give us some insight into their lives. It occurred to us that though a number of you have do so, we hadn't done this with our own Roses! That is why in this issue you are seeing an account of our California branch that came from Limestone/Lauderdale Counties in Alabama, and before that from White and Giles Counties, Tennessee, Surry and Wilkes Counties, North Carolina, and Stafford and King George Counties, Virginia.

Members trace such a variety of families. The ROSE descendants do not all trace to one country, or one family, as many other U.S. families do. Even in early Virginia we can find many separate Rose families before 1800. The items in our issues show the diversity. English/Scottish is a large part of the early immigrants, but also many from Germany and some from France, Barbadoes other localities.

Their son Edward, who was only four when his father died, later in life became publisher of the *San Jose Post-Record*, a court and commercial newspaper. His son Earle Tarleton Rose later succeeded him. Still later his grandson Seymour Tarleton Rose, who had grown up as a printer in the business, became the publisher until his retirement in the early 1990s.

Seymour and Christine searched for 3-4 years to find the Rose family before their arrival in California. Seymour's grandfather tried to recall bits and pieces he had heard – he was only a small child and never really knew his father. He remembered they were from northern Alabama, and that a relative had been sheriff of Lauderdale County. Finally, we found a genealogist in Alabama who provided their 1850 census. With that information and many letters we eventually made contact and arranged a trip to Alabama in a small 16 ½ travel trailer with our four small children. Though we were very excited, there was still sadness for Seymour's grandfather died about three years before we found them.

What a trip! Our relatives had planned a reunion and what a thrill it was. Hundreds of Rose relatives attended. William J. had several nieces and nephews still living, in their 70s and 80s, and they met Seymour with tears in their eyes. They had never expected to meet a family member from the California branch. They remembered their fathers recounting how they accompanied their brother to the Elk River and said their goodbyes, never to see him again.

We visited so many – in their homes, their cabins, and sat enthralled as they passed down the stories they had heard. We sat on the porch of one of our hosts, the Millers, with the cornfields across the road and the fireflies lighting the night, and listened for hours to the stories of those we had so yearned to know. It was a reunion we will never forget – the first of many trips we made to Alabama. We still visit the area every two or three years to re-connect with relatives, to visit the gravesites, and just soak in the area where these family members lived. The fifty plus years that have passed since then has never dimmed our awe and thrill and emotion of that first visit.

A Fascinating Glimpse at Six Brothers

THE ISAAC ROSE FAMILY OF LOUDOUN COUNTY, VIRGINIA; DESCENDANTS TO KENTUCKY AND OHIO FROM AN "OBSCURE" VIRGINIA DOCUMENT

Editor located this wonderful record of these brothers from the manuscript records at the Virginia Genealogical Society (now Library of Virginia) in Richmond many years ago. It is a remarkable record as readers can see. This family came to mind when recently finding the following newspaper item from the website www.virginia.chronicle.com, taken from the Genesis of Liberty #46 of 27 November 1821:

MARRIED, on Thursday evening last, by the Rev. Jno. G Watt, Dr. WILSON to Miss Charlotte Rose, youngest daughter of Capt. John Rose
...

Recognizing that Charlotte was the daughter of Capt. John Rose and his wife Anna Beall of Loudoun County your editor thought members would be interested in seeing what can be found by pursuing documents. Other documents were also found pertaining to this family's service.

[LAND BOUNTY] ARMY

Affidavit: John Rose, brother and heir of Richardson, Isaac and William Rose, decd. of the Virginia line of Continental Troops in the Revolutionary War, appoint George Richards of Leesburg, Loudoun County, Virginia lawful attorney for any claim against the State of Virginia or the General Government of the United States for bounty lands due to the said Richardson, Isaac, William Rose. Dated: 10 March 1835. Signed: Jno

Rose. Wit.: C. F. Wilson. Ack.: 10 March 1835 in Loudoun County, Va. personally.

Report on Claim: I have not found Richardson Rose's name on Army Register of Continental Line. The name of Richard Rose is there, certificate issued to him, delivered to Col. Hawes? December 4, 1784 for £-44.3.4 the balance of his full pay. William Rose's name is on the Army Register twice. He received £-23.8.0 the balance of his full pay Sept. 3, 1783, certificate delivered to Samuel Johnston. Wm. Rose also received, Oct. 9, 1784, the balance of his full amount £-84.14.6, for which the certificate was delivered to John Marshall. Isaac Rose is also twice named, certificate for balance of his pay £-60.18.3 April 21, 1784 delivered to Col. G. Mason. Another certificate issued 3 May 1784 in the name of Isaac Rose for £-15.12, balance of his full pay, delivered to James Norwood. (See Army Register of the Continental Line for proof.) It does not appear that Richardson Rose has received bounty land. A Wm. Rose, soldier of continental line, received? 100 acres of land for his services. Isaac Rose, a Corporal of the Continental line, has received 200 acres for his services. The petitioners have filed the affidavit of John Rose, a respectable man, who testifies as follows:

That Richardson Rose enlisted in the company of Capt. Fitzgerald, in the 3rd Va. Reg., commanded by Col. Weedon?, that he enlisted in the year 1775 when the Regt. was raised and for the war, that said Richardson Rose was at the battle of Gwinn's Island, went to the north with his regiment, and died in the service at White Plains in the winter of 1776. The witness further says that he was informed that Richardson Rose was a Ser-

geant before his death.

That Isaac Rose enlisted in Fairfax County, Virginia in Capt. Thomas Wests? Co. of the 6th Va. Reg. commanded by Col. Stephens, that he enlisted in the fall of the year 1776, for the term of 5 years, was at the battle of Brandywine, Germantown, and Monmouth, and wintered at Valley Forge in 1777, that he served his term of five years faithfully, and was discharged in 1781.

That William Rose enlisted, at the age of 18, at the same time and place, and in the same company with his brother Isaac, for 5 years, was marched to the north in the year 1777, and was then appointed Sergt. Major, that he was at the battle of Brandywine, where he was killed by a ball in the breast, whist acting (as the witness has heard) as Ensign. The witness John Rose is one of the heirs of the three brothers, Richardson - Isaac - and William Rose decd. The above are all the facts which have come to my knowledge in the investigation. Signed: John H. Smith, Comr? May 25 1835.

Affidavit: James Rose of Champaign Co., State of Ohio, a brother and heir at law of Richardson, Isaac and William Rose decd of the Virginia Continental Line, appoint George Richards of Leesburg, Loudoun County, Virginia lawful atty to ask, demand, sue for claim which I may have against State of Virginia or General Government of the United States. Dated: 26 Jan. 1835. Signed: James Rose. Wit.: Geo. B. May? Ack.: 26 Jan. 1835 personally in Champaign Co., Ohio.

Letter: Leesburg, Loudon Co., Va. May 15, 1835 to J. H. Smith, Esq., it was not until recently that I was made acquainted with the rule of Gov. Tazewell? of Aug. 18, 1834, I now perceive why the cases of the Roses and Solomons were not acted on, they having been recd after the adoption of that rule. I am sending (memorial) to the Roses...in James Rose's letter to me he says his brother Richardson was a Sergeant, John Rose says he heard the same thing. Isaac Rose was a Private for 5 years. William was Sergeant Major and probably an Ensign, killed in Battle at Brandywine. Entered the service for 5 years. Signed: Geo. Richards.

Memorial: Of John Rose of Loudoun County, Virginia, represents that his brothers Richardson Rose and William Rose served in the Virginia Line of Continental Troops in the War of the Revolution, memorialist knows that his brother Richardson was about 23 years old when in 1775 he enlisted for the war in Fairfax Co., Va. in a company commanded by Capt. Fitzgerald, 3rd Va. Reg. commanded by Col. Weedon, he went into sd regiment early in 1775 when it was first formed, was at Gwinns Island in Chesapeake Bay, etc. [gives service], Richardson died in service at White Plains in the winter of 1776, father and family received information of his death by rheumatism. Isaac Rose was about 21 when he enlisted for 5 years in the fall of 1776 in Fairfax County in Col. Stephens 6th Va. Reg., Capt. ---? Wests Co., Isaac served out his 5 years and was discharged. In 1794 he came to live with memorialist at his farm in Loudoun County and heard him say he was in battle of Brandywine, Germantown & Monmouth, and was at Valley Forge, Pa. in winter of 1777. And respecting William Rose, he was about 18 when he entered the army for 5 years at same place, Fairfax Co., Va. and in same company and regiment with his brother Isaac, on account of his youth his father was opposed to his entering the army so young. Early in 1777 when the regt. marched to the north William was made Sergeant Major, etc. These facts your memorialist believe to be true, your memorialist was born 1761 was 14 in 1775. All three brothers mentioned died unmarried and without issue, and the legal representatives are first, **your memorialist, residing in Loudoun County, Va., second, his brother George Rose, if living, residing in Harrison Co., Ky., and then, his brother James Rose, if living, residing in Champaign Co., Ohio.** Signed: Jn Rose. Personally acknowledged 15 May 1835, Loudoun Co., Va.

Ed. note: How lucky anyone tracing the above family is to have such a record! Yet, it is one that would not have been easily found.

Joseph Benson Rose II, son of George Rose II and Mary Josephine Maginnis



Joseph Benson Rose II, was a great-grandson of George and Nancy (Fordyce) Rose of Guernsey County, Ohio and Ulster County, New York.

The following information provided by member Benson Rose who has accumulated a vast amount of records on this group of Roses. They are descendants of Aldert H. Roosa of Ulster County, New York.

Joseph Benson Rose II and his brothers and sister lived on Long Island as royalty due to the money inherited by his father George Rose II from his father Joseph Benson Rose I. He attended boarding school and prep schools for his education and rode horses, hunted and traveled.

When WWI broke out, the British were not able to obtain the manpower they needed. The Canadians were sent to U.S. cities to recruit for the fight. JBR II joined that effort. JBR II was trained in Texas and stationed in England. After the war he remained in the latter place and attended Oxford University. He returned to the U.S in 1919. He then left for St. Paul, Minn. where he worked as a bank teller. There he became a friend of F. Scott Fitzgerald and Zelda. And there JBR II met and married Eleanor Connely Mitchell.

Later they moved to Italy to improve JBR IIs polo skills. In 1926 he was on the team that won the Brioni Cup. Then to Paris and more polo until WWII broke out.

Washington County, Virginia

Jack Hockett has notified us that his newest book on Washington Co., Virginia records is available from Iberian Press: *Washington County Virginia Minute Book 18, 1869-1870* Jack Hockett. 2017, 8x10, vi, 260 pages. If you are tracing any family of this county you are indeed fortunate to have the many publications of Hockett to assist you.

LITTREL allowed to enter recognizance in amount of \$20 for appearance... he does so with D. F. BAILEY, R. S. LOWRY and I. F. JONES, who offer like bond.

Peleg and Mary (Spicer) Rose

POQUETONNOCK CEMETERY, PRESTON, CONNECTICUT

Peleg Rose was a descendant of the Joanna Rose family of Stonington, Connecticut. His line: Peleg⁵, Robert⁴, Joseph³, Thomas², Joanna¹. Peleg's wife was Mary Spicer - she is buried next to him.

Joanna Rose's husband's name has not been absolutely proven but because of an engraved piece of cutlery it is believed her husband's name could have been Thomas Rose. It is assumed he may have died before she removed to the colonies, or he may have died soon after.

Sevier County, Tennessee

From Betty Foster we received a verbatim transcription of some court actions from the Circuit Court records of Sevier County, Tennessee. We abstracted them as follows:

Monday 18 March 1862, p. 17

State vs Alexr. Rose, A & B [Assault & Battery]

The Grand Jury returned an indictment against Alexr. Rose for assault and battery.

Monday 6 April 1863, p. 44

State vs Benjamin Rose, A & B [Assault & Battery]

Grand Jury returned an indictment against Benjamin Rose for assault and battery.

Tuesday 18 July 1865, p. 145

State vs Benjamin Rose, A & B [Assault & Battery]

Cause continued until next term and thereupon came deft with A. W. Rose his security and acknowledged themselves indebted to State of Tennessee each for \$250 to be levied of their respective goods and chattels lands and tenements to be void if defendant shall make his personal appearance at Sevierville third Monday of November next to answer a charge of assault and battery, etc.

Wednesday 22 Nov 1865, p. 225

State vs Benjamin Rose, A & B [Assault & Battery]

Cause continued by consent until next Friday

Friday 23 November 1865, p. 257-258

State vs Benjamin Rose, A & B [Assault & Battery]

Came the State by Attorney General and defendant appearing...being charged...say that he is [erased] guilty as charged ... thereupon came a jury to wit, G. W. Hurst, Henry Baker, V. Hickman, Henry Newman, James Johnson, H. P. Ward, R. W. Underdown, J. M. Murphy, J. W. Sutton, G. W. Whaley, Geo. E. Burket & John Howard...say the deft is guilty. [It is unclear why there would have been a jury trial if his plea was guilty.]

Tuesday 17 November 1868, p. 346

State vs Alexr. Rose, A & B No. 1, it appearing to the court that more than two capias have been returned in this cause "not found" it is therefore ordered that this cause be stricken from the docket.

Sevier County Circuit Court

State vs Alexr. Rose, A & B No. 1, Stricken from docket. [A list of costs included]. Bill of costs certified Nov. 17, 1868.

Tuesday 17 November 1868, p. 347

State vs Alexr. Rose, A & B No. 2, similar to p. 346 above, and a Bill of Costs included, certified Nov. 17, 1868.

Circuit Court betw. Nov. 1868 and Nov. 1869, p. 547, from County Court. Martha C. Rose vs Benja F. Rose, O. N. Lanning, J. M. Thomas & others. The deft J. M. Thomas by attorney entered a motion to dismiss the petition in this cause for want of a prosecution bond.

Martha C. Rose vs B. F. Rose, Arch Rose, Sallie Rose, Mattie Rose, Geo. Rose, O. N. Lanning, Malinda C. Lanning, Mitchell Thomas, Mary J. Thomas and J. M. Thomas, Appeal from County Court. This day came Jas. W. Chambers & A. M. Chambers and acknowledged themselves security and agreed and undertook that plaintiff in case she fails to prosecute this suit with effect that she shall pay the costs or they will pay for her.

John B. Rose, 90, died Jan. 18, 2017 at LaSalle County [Ill.] He was born June 24, 1929 in Putnam Co., Missouri to Marshall and Beva (Hanel) Rose. He married June Leibold Heitel on June 3, 1989; she passed away Jan. 27, 2013. He was an Army veteran. Survived by stepsons and step-daughters and others. 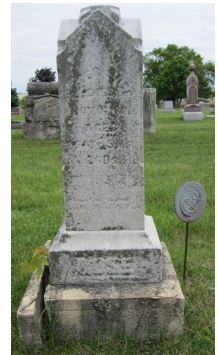

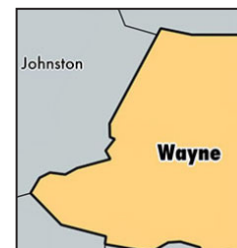

William Templeton Rose of Indiana, Missouri etc.

William Templeton Rose, parentage unknown, has been an enigma. He was born 25 March 1823 (tbs.), died August 1896 (tbs.), buried Edwards Cemetery, Taney County, Missouri. He was born in Illinois (1850 and 1860 federal census) or Ohio (1870 and 1880 federal census and 1852 California state census).

He married 1st, 5 February 1845, Warren County, Indiana VR [Vital Records], Hester Ann "Hetty" Odle/Odell. (Her name shown as Hetty Ann Odle on the marriage records.) She was born ca 1828 (1850 census), and died 1857-1860. Her parentage is unknown.

He married 2nd, ca 1858-1859, Irene (Irena/Arrena) Taber/Tabor, born 1825-1827, Virginia (census), died 1880-1890, her burial and parentage unknown. He married 3rd, 20 July 1890, Taney County, Missouri VR, Deborah Caroline

Clark (shown as Caroline on marriage license), the marriage performed by Leroy Thomas, M.G. Her dates and parentage are unknown. DNA testing of a descendant in 2006 indicates that there is a connection to the family of John and Dorothy Rose of Shenandoah Valley, Virginia (later to Pickaway County, Ohio).

From editors' trip to this county. E. B. Rose is probably Elisha B. Rose, son of John Rose of White County, Tennessee. There is a connection to Group L of the YDNA project.

Massachusetts CATHOLIC RECORDS

The New England Historic Genealogical Society (the repository housing our huge Rose Family Association collection) has an important database of interest to those with Catholic ancestors in this state.

The records from the Cathedral of the Holy Cross are now available in Massachusetts: Roman Catholic Archdiocese of Boston Records, 1789-1900. This update includes over 555,000 names searchable by first name, last name, parents' names, spouses' names, witnesses' names, record type, year, and location.

This collection is available to members of the New England Historic Genealogical Society (NEHGS) through their americanancestors.org website. A quick look disclosed more than 700 Roses listed, many of them in the 1800s. Wonderful evidence of maiden names, parentage etc. are shown in these records.
