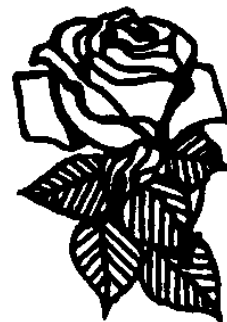

William Henry² Rose (Ira B.¹ of McLean County, Illinois), known as Henry Rose, born 25 October 1844, Martinsville, Clark County, Illinois (Civil War pension file), died 29 January 1933, Mound City, Linn County, Kansas, buried Farliurville?, Linn County, Kansas (Ibid.; his d.c. shows he died aged 88y 9m 4d, at Mound City in Linn County, buried Wa---? Grove); married 9 October 1870, Clark County VR, Mary Ann Ashby, who died 12 July 1911 (Ibid.). The marriage was performed by P. F. Thornburgh?, M.G.

He served in the Civil War as Henry Rose in Co. G 123 Ill. Infantry, Union, and later applied for a pension.

From his Civil War pension, National Archives: Affidavit: Linn Co., Kans., 24 June 1914, Henry Rose, aged 70, resident of Parker, Linn Co., enl. 14 Aug. 1862, Priv., Capt. Reason R. Lovelace's Co. G 123rd Ill. Inf., disch. Springfield, Ill. 28 June 1865, 5' 9", fair compl., grey eyes, dark hair, farmer, b. Apr. 25, 1844 at Martinsville, Ill. Since service lived Clark and McLean Cos., Ill. about 22 years, near Holyoke, Col. for about 8 years, rest of time in Linn Co., Kans.

Affidavit: Linn Co., Kans., 21 July 1927, Henry Rose, aged 23, b. Apr. 25, 1844, Martinsville, Ill., enlisted Aug. 14, 1862 at Mattoon, Ill., Co. G 123 Reg. Ill. Inf., disch. June 28, 1865 at Nashville, Tenn., 5' 9", fair compl., brown eyes, black hair, farmer, resided since service in Ill. 1865-1887, Holyoke, Col. 1887 to 1894, Linn Co., Kans. 1894 until present, gives disability. Signed: Henry Rose, Mound City, Linn Co., Kans. Wit.: J. H. Marrs, J. M. Hahan.

Application for Burial Flag: Application made for a burial flag to drape the casket of Henry Rose, who died at Mound City, Kans. Jan. 29, 1933 and who will be buried at Farliurville, Kans. Signed: Jan. 31, 1933: Selma E. Rose.

Will of JOHN ROSE of Germantown, county of Philadelphia, Victualler; lst, directs debts to be paid, then bequeaths to son George Rose best dearborn? and best horse. To my wife Mary Rose residue of my estate to dispose of as she pleases. After her death, estate to be divided between my 11 children as tenants in common and not as joint tenants, 1 share in trust to my son William Rose to pay to Sarah Apple and her heirs, one share to Phebe Rickeson, 1 share to Mary Peterson, 1 share to Susan Nauney, 1 share to William Rose, 1 share to Eliza Krickbaum, 1 share to Sophia Snyder, 1 share to George Rose, 1 share to Caroline Rose, 1 share to Henrietta Rose, 1 share to John Rose, being all children of said John Rose, the testator. Appoints wife Mary Rose and son William Rose executor and executrix. Dated: 17 Dec. 1828. Signed: John Rose. Codicil appoints in addition son George Rose as executor. Will Proved: Nov. 27 and 28, 1833. [Codicil also in file; info not taken]

Shay's Rebellion

CHARLES ROSE

Though the Revolutionary War ended in 1783, some rough times followed. Especially in western Massachusetts where a downturn in the economy resulted in many being jailed for debt. The result was an armed uprising that wasn't over for about six months, starting at the end of 1786 and start of 1787. The leader was Captain Daniel Shays (1747?-1825), a veteran of the Revolution and a farmer from Pelham.

"The Supreme Judicial Court soon sentenced fourteen of the rebellion's leaders, including Shays, to death for treason. They were later pardoned by the newly elected Governor John Hancock. Only two men, John Bly and **Charles Rose** of Berkshire County [Mass.] were hung for their part in the Rebellion.

Dr. Ferdinand Rose and his wife Lucy Halterman are shown above. Rev. Ferdinand³ Rose was the son of Charles² (Joseph¹ Rose) of Montgomery County, Virginia and Jackson County, Ohio). He was born 28 June 1835, Ohio, and died 8 October 1912, in Jackson County, Ohio. He married 11 March 1858, Jackson County, Ohio VR (married by Isaac Brown, Rev., p. 236), Lucy Halterman. She was born ca 1838, Ohio. We published his obituary on page 5366 of the September 2009 issue in which it was stated that it was "very largely attended last Saturday afternoon, one of the largest funerals the town has had in years."

Though brief, it left valuable military, pension and other records.

HENRY F. ROSE PASSES AWAY
Well Known Lawyer Succumbs to Heart Trouble

HAS BEEN AILING SINCE MAY

Dissolution Comes at 7 o'clock This Morning -- Tribute Paid Him by Maurice McKenna

Henry F Rose, one of the oldest members of the Fond du Lac county bar, both from the standpoint of years and length of practice, passed away at his family home, No. 92 East Division Street, this morning at 7 o'clock. A peculiar coincidence of his death is that at the death of Mrs. Rose, two years ago in August, he remarked that he would not live more than two years after her.



Mr. Rose has been ailing since May, and for the past six weeks he has been confined to his bed, the nature of his illness being heart trouble. He was born in New York state seventy-seven years ago, and came to Fond du Lac in 1853. He was graduated from the law department of Union college, Schenectady, N.Y., in 1849. Immediately after the Civil War the deceased began the practice of law in this city, and has been continuously so engaged in this city since that time. He was appointed court commissioner for Fond du Lac by Judge Gilson, and has acted in that capacity until a year ago. He is survived by four daughters, Mrs. Arch B. Eldredge, of Marquette, Mich.; Mrs. William M. Lewis, of Racine;

Miss Georgianna M. Rose and Miss Percie B. Rose, both of this city; also two sons, Judge Henry Howard Rose, of Los Angeles, Cal., and Robert Selden Rose, of Marquette, Mich.

Maurice McKenna, president of the Fond du Lac county bar, who has enjoyed an intimate acquaintance with Mr. Rose for the past forty years, paid the deceased a fitting tribute this morning, when he characterized him as one of the best read lawyers Fond du Lac has ever had. "I knew Mr. Rose forty years ago," said Mr. McKenna, and during that time I have never heard him spoken of except as a man of strict integrity, a most capable attorney, and as the soul of honor itself. I remember when I studied law with Mr. Rose. It was the second year I studied, and he was at that time occupying an office over the old First National Bank, which was a wooden building. Mr. Rose has been regarded by members of the bar as one of the best read lawyers Fond du Lac has ever had. He knew the law, and was a careful pleader. "He never figured much in court trials because of his nervous temperament, but he would sit down and draw a pleading on paper as well as any man. I have always had a feeling of gratitude for Mr. Rose for the schooling he gave me, and I know Owen A. Wells, who also studied in Mr. Rose's office, will voice the same sentiments."

Arrangements for the funeral are being held in abeyance pending the arrival of relatives but it will probably be held Wednesday.

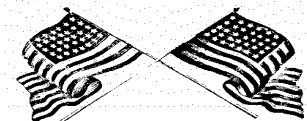

GREAT-GRANDSON OF LEMUEL ROSE



Capt. Joel L.⁴ Rose (Daniel³, Phineas², Lemuel¹), was born 2 October 1838 (g.s.), died 27 April 1913 (g.s.), buried Port Republic, Atlantic County, New Jersey. He married 1st, Susan ---, married 2nd, 7 January 1860 (IGI), Lovenia S. Reed, born 15 March 1840 (g.s.), died 21 September 1905 (g.s.), buried with husband.

From a biography of his son Horace L. Rose in *South Jersey-A History* by Alfred M. Heston, Capt. Joel L. Rose, a native of Absecon, New Jersey, was a sea captain until his death in May, 1913, in Camden [New Jersey]. He was the official commander of a privateering vessel during the Civil War, according to this source. This further shows that he married Lovenia Reed, daughter of the "well-known Edward Reed, of Absecon."

[here follows a list which includes among others "Sergeant Rose, of Company L, led us all, and almost cut a road for the rear ... [Signed] J. B. McIntyre, Captain, Fourth Cavalry, Commanding Regiment. [Evidently sent to Capt. Robert Burns, Adj. Asst. Adj. Gen., First Brig., Second Cav. Div.]

Editor and Audrey Wilson exchanged information on this family in the early 1980s. Audrey had done considerable research on the family. Putting together what she found, and what the Rose Association had, we determined that:

Libbeus Rose, parentage unknown, was born 15 June 1812 according to his death certificate in Audrey's possession. He died 2 February 1842 in Paynette, Columbia County, Wisconsin, from the same certificate. He is believed to have married a wife named Caroline who was born ca 1812 in New York (from 1850 census) though her death, burial and parentage are unknown. However, other data indicates he married Sabra Ann Donaldson who was born 14 March 1810, Butternut, Orange County, New York and died 6 February 1842 in Paynette, Wisconsin of "La Grippe: four days after her husband.

It is uncertain whether he had two wives since the 1850 census shows a Caroline in the home while 1860 shows Sally Ann. However, it could be an error on the census.

The death certificate, in possession of Audrey Wilson, shows him as white, male, age 79, retired farmer, born Broome County, New York, wife Sabra A. Rose. Additionally, that he was born 10 June 1810, died 2 February 1892 of "La Grippe at Poynette, Columbia County, Wisconsin. [The death certificate of son Albert Ogden Rose, Los Angeles County, California, city of Long Beach, #211, Albert was born November 13, 1839, died June 20, 1916 aged 76y 7m 6d, male, white, widowed. Father shown as Libbeus Rose born New York and mother as "Saber Ann Donaldson" birthplace unknown. Informant: Jesse Rose, Bard, Calif.

Comments: Can we be sure that the military file (i.e., pension in particular) is the "final" word in a case? No! It is prudent to check the Congressional Records to see if future actions came up either regarding an increase in pension, restoring of a pension, etc.

How do we do that? Check the "Government Docs" section of a library (not all libraries have these) and check indexes to the Congressional Records. Ask the librarian's help if necessary. In this case, note that in 1907 it came before congress to grant Joseph Rose of Sherman Heights, Tennessee, who served in the War with Mexico, a pension based on age and disability. This came before the House of Representatives (shown at the right) and in the Senate (Report No. 5380 not shown here). Though your editor did not follow this further, there should later be a Bill in the U.S. Statutes at Large, which would be the final step in the process of granting this pension. There should also be items in the "Congressional Record" for 1907.

Leland Rose of Sauk County, Wisconsin

BY LUCILLE ROOF

Leland was born, 1903, and raised in Sauk County, Wisconsin. He was the son of Allan and Ida (Townsend) Rose. His father died there in 1918. After Leland returned from World War I in France, still weak and coughing, he and his only brother, Erwin, traded farms with Philip Steber, moving to Grant Township, Monroe County, 1920, with their mother Ida.

The Rose brothers worked on town road construction, hauling shale with horses and sleighs. They also had a cream route.

Uncle Hugh Rose lived here, serving as the blacksmith, gardener, and smoked meat. Leland served on school and town boards. Sometimes the school teachers boarded at the Roses during the winter months. Hard times were beginning, but life was never dull at the Community Hall.

Erwin enjoyed those parties but never married. The love-bug bit Leland and Gertie, daughter of Daniel and Anna (Burchell) Paddock, the wedding taking place October 1928.

Now hard times multiplied. Ida Rose and Uncle Hugh died, there were two small children and Gertie had a goiter operation. In the fall of 1932 the bank took their home. Moving was sad.

The small house on the 120 acre farm in the town of Lincoln, purchased from Etta Woodard, was little more than a shack. Cows became sick and died. There was no radio of course, but Tom and Nate Paddock visited on their way to and from Tomah. Brother, Erwin, was renting a farm nearby. There were wonderful neighbors who helped the family survive one of the worst winters of their lives.

Victor Eugene was born 1934, joining big sister, Lucille, and brother, Daniel Allan. Bessie Ebert came to help at that time and two years later she was there when daughter Bessie L. was born. At Christmas in 1936 the baby became very ill and nearly died.

Now the house had to be enlarged. Neighbors helped and children watched wide-eyed as Mom cooked and washed outside.

Doctor, dentist, and house payments were made with farm produce: eggs, potatoes, blackberries, etc.

By 1941 Benjamin Hugh and Alvin Aaron were born. Leland started working for the County Highway Department in 1944 with Rube Purdy.

In 1940 Erwin built a tiny house east of Leland's home. He worked for neighbors until his death in June 1955.

As young adults, Benjamin and Alvin started tinkering with tractors and cars, remodeling and repairing them. Alvin was so engaged when a car fell on him, crushing him to death in November 1961.

A heart attack brought retirement and many happy days with grandchildren. Benjamin and wife Lou Ann (Pasch) took his parents on a trip to Washington State to the World's Fair in 1962 and visited Daniel and

wife B. Martonne Rose there. Benjamin was an auto mechanic in Tomah. They raised a daughter Sheila and a son Alvin Aaron.

Leland died in Tomah of cancer in 1966. Gertie had been a member of Kirby Homemakers for over twenty-five years and enjoyed a small home in Tomah the last fifteen years until she died in May 1981.

Remember too to check for a separate pension application by the widow of the soldier.

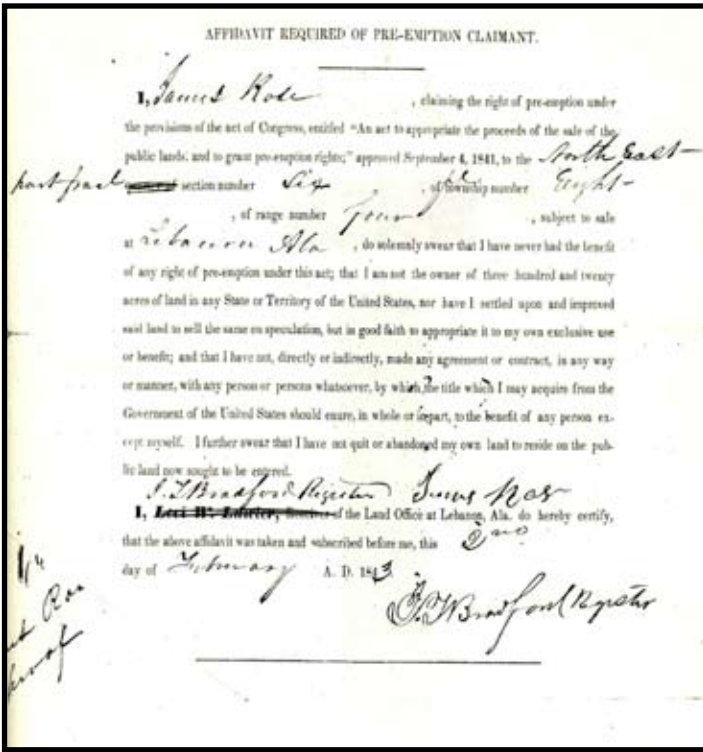

FEDERAL LAND ENTRY PREEMPTION

To the left is part of the Federal Land Entry File of James Rose under the Preemption act. It is one of four papers in his file. The information on Preemption entries varies, but sometimes will include how long the person lived on the land, affidavits of neighbors as to their knowledge of the facts, etc. If the entry is approved, a Final Certificate would be issued. That was then presented to the Government Land office and a patent would issue. However, once James Rose received his warrant he could have sold it and in that case the assignee would apply for the patent. The patent itself, which should be available at www.glorerecords.blm.gov should be available.

Using the search box at the glorerecords.blm.gov website, a search was made for Alabama, James Rose, and the boxes for patentee AND warrantee were checked. This was done so

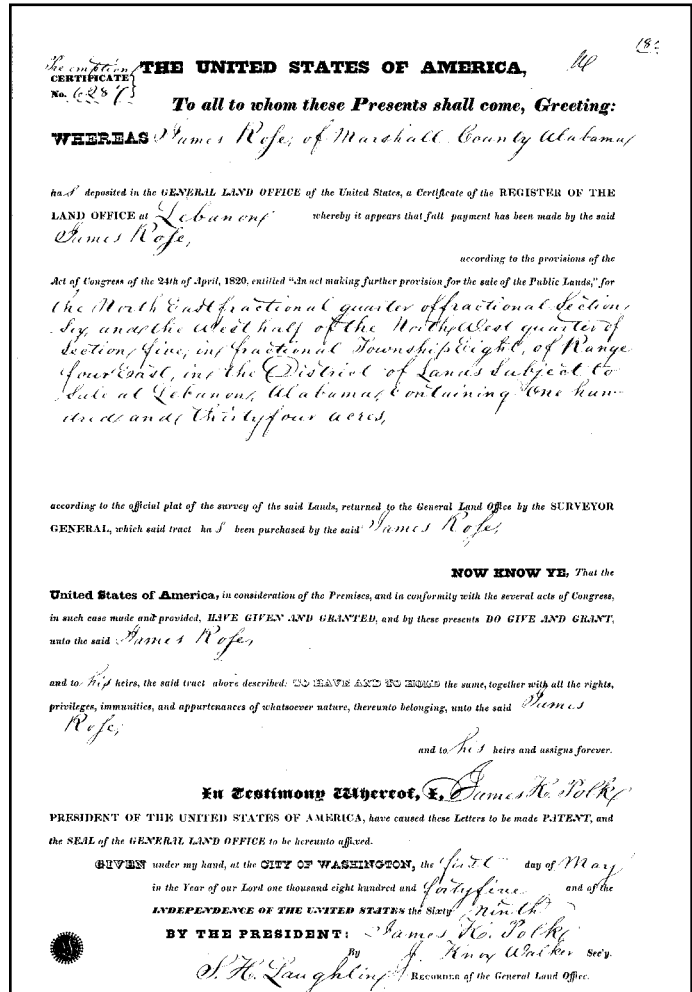
that whether he had sold or assigned the warrant we would still find it. The items that were listed were then examined and his patent found as shown here.

Whenever working with federal land records, we should keep in mind that every patent for land issued should have an associated land-entry file. If it is for bounty land (for military service) it is a bit different but is available as a bounty land application file. A wonderful plus of the land-entry file is that this file often has the signature of your ancestor! James² Rose (Howell¹), was born ca 1809 Ga., died between 9 October 1857 (will) and 5 December 1857 (will proved), Marshall County, Alabama. James Rose married ca 1832, Margaret McKee, born ca 1812, Tenn., died after 1860, daughter of William McKee of Marshall County, Alabama.

James Rose was murdered by Abner Parish or Paris...case appealed to Alabama Supreme Court (vol. 36 Alabama Reports). One of the bases for appeal was that he was indicated as "Abner Paris" and his name was "Abner Parish." Appeal denied. Execution ordered. (The 1860 census of Marshall County shows "Abner Paris" in jail.)

Note: The ancestry of James' father Howell Rose is uncertain.



Philip Rose, descendant of Frederick Rose of Tennessee

This is from Old War Pensions, National Archives, Washington, D.C., file #17557. Old War pensions were granted usually to invalids or U.S. Army for those with wounds received in service.

Waynesboro, Wayne Co., Tenn., 2 [May?] 1859, Philip Rose incapable of performing duty of soldier because of disease, chronic rheumatism, suffered much, is wholly unable to walk. Signed: W. L.? Childress, R. W. Couch?, surgeons.

Affidavit: Wayne Co., Tenn., 1 Nov. 1858, Philip Rose, citizen of Wayne, aged 63 and 2/3, was resident in co. of Orange, N.C. when in year 1814 drafted, Capt. James Graham, Col. Hunter, attacked with measles, discharged 20 Feb. 1815; in 1843 became worse, hasn't been able to walk for four years. Signed: Philip Rose.

Affidavit: Wayne Co., Tenn., Elizabeth Cook, aged about 69 and Eli Rose, aged 63, have been acquainted with Philip Rose, that sometime about first of March 1815 he returned from service, sick, have been well acquainted with said Philip ever since that time. Signed.

Affidavit: Wayne Co., Tenn. 25 Oct. 1859, Philip Rose, aged 64, resident of Wayne, Priv. Capt. James Graham, removed to Bedford Co., Tenn. in year 1816, and in 1817 removed to Wayne Co., Tenn., he has resided in Wayne and Hardin counties ever since, farming, recently received letter from his cousin Austin Rose residing in the neighborhood from which he [claimant] removed in N.C. stating that his Capt. is now dead. Signed: Philip Rose. N.Y. Brown and J. F. Hall, residents of Wayne, attest.

[There is a separate land bounty file for Philip Rose.]

Editor's note: Philip⁶ Rose (Frederick⁵, William⁴, Richard³, Richard², William¹), born ca 1794-1795 (census), North Carolina (census), died January 1860 age 66 (1860 mortality schedule), Wayne County, Tennessee (ibid.). He married, date unknown but married by January Term 1824, Sarah () Williams, born ca 1790-1794 (census), Tennessee or Kentucky (census of 1850 and 1860 respectively). He was living at the time of the 1870 census. James Graham, and in the service of the United S. as aforesaid. This the 10th day of November 1. Eli Rose

Though documents such as the above do not appear in every file, some do have affidavits by other Roses which would imply a relationship as do the helpful statements of Elizabeth Rose and Eli Rose as shown.

Walden Rose, 20 years of age, was fatally insured and died. He was employed as a brakeman by the Brunswick Lumber company and was working in the mill yard when heard. Taken to Swanson's undertaking in Marquette for shipment to Baraga will be made. Survived by parents, Mr. and Mrs. Arthur Rose, three brothers, Ellerd, Ivan and Raymond, and three sisters, Isabelle, Eileen and Nisagmi. Rose came here from Munising with his parents about

a year ago.

Isia Bud Rose aka Isabud Rose (1850-1934)

The following was submitted by Rosemary C. Davis a number of years ago. Her Isia Bud Rose was a son of John and Mary Ann (Wilson) Rose of Tennessee and Grundy County, Missouri. After John's death his widow Mary Ann married in Neepton County, Missouri, to William Milstead. The ancestry beyond John is not known.

Isia Bud Rose was born on May 15, 1850 approximately 15 miles from Cumberland Gap, Tennessee. In the next few years his father made several trips to Missouri, presumably to look for a new place to settle. Then, when Isia Bud was 9 years old, he moved with his mother to Missouri.

The 1860 census of Neosho, Missouri, shows him in the household of his parents, John and Mary Ann (Wilson) Rose. Also in that household were his brothers James and John.



In June, 1861 the father, John Rose, joined the Confederate forces and served in Company A of Hoods (or Woods) Regiment of Missouri Cavalry. Captured at Longview, Ashley County, Arkansas, in early 1864, he later died in a Union prison on May 24, 1864. He and his twin brother William, who was in the Union Army, are both buried in Fort Smith, Arkansas, in the Cemetery for Civil War soldiers.

After the death of her husband, Mary Ann Rose married a Mr. Milstead, an ex-whaling ship sailor, in Neosho, Missouri, and they moved to Coreycelle County, Texas. She had two more sons by this marriage. She died presumably before 1880, and is buried in or close to Marlin, Texas.

Isia Bud Rose remained in Missouri for a time after his mother left, and then went to Texas to join her in 1869. He seems to have been motivated not only by the wish to be with his family but also by a desire to hunt buffalo. This was during the years of the great American slaughter of the buffalo, and the family story is that he killed 1,200 of them. This gave him a good financial base with which to begin life in Texas.

In 1871 he married Hannah Susan Huffman, daughter of Dr. David E. Huffman and his wife Elizabeth "Betsy" Bybee. The Huffmans gave the young couple a few head of cattle with which to start married life.

I. B. and Hannah Susan moved to Dublin, Erath County, Texas, before Ollie Victoria Rose, my maternal grandmother, was born on December 25, 1876. The family later moved to Breckenridge, in Stephens County, and then to Coleman, in Coleman County, before moving to Midland, in Midland County, around 1888. From Midland, Texas, they moved to Roswell, Chaves County New Mexico in the fall of 1899. At that time, I. B. Rose moved the largest herd of sheep in that area from Midland to Roswell.



In 1902, Isia Bud Rose and his oldest son, John Rose, together with some others, organized the Roswell Lumber Company. I. B. served as president from 1902-1926 until the company was bought by Big Jo Lumber Co.

He and his wife Hannah Susan (Huffman) Rose had ten children: John; Blueford (who died in infancy); Ollie Victoria; Benjamin Franklin; Joseph E.; Howard L.; David Edward; Clarence Addison ("Man"); Elmer Aubrey ("Pete"); and Marsha (who died in infancy). Hannah Susan Rose, aged 77 years, died in Roswell, New Mexico, on March 6, 1934. Isia Bud Rose, aged 84 years, died in Long Beach, California, on September 11, 1934. Both are buried in the Roswell, New Mexico, cemetery.

Member Connie Grund #2278G01 sent an item from the Summer 2013 issue of Cahawba Genealogical & Historical Society's (Selma, Alabama) Vol. 2 No. 2 . In an article on Castle Morgan: Captivity Inspires Career Choice, submitted by a great-granddaughter of Samuel Jenkins, it is mentioned that he survived his prisoner-of-war experiences at Castle Morgan. Samuel was mustered into Co. L 3rd Tennessee Cavalry in 1864. Nathan Bedford Forrest's troops captured him near Athens, Alabama. Jenkins survived and married Elizabeth Jane Rose. When she died, he had seven children to raise. At 46 he received his medical degree. He again married, had 13 more children, and lived until 1933. A photo of Samuel and Elizabeth Jenkins appears in the issue.

Member J. Benson Rose #2999R05 tells us that he had quite a shock when viewing the September issue online.
